## SUBDIVISION FACTSHEET Preliminary Plat Review – December 6, 2021

NAME: Hatteras Island Reserve Phase 2

LOCATION: Hatteras, NC

**SITE SPECIFICS:** Total site area: 3.36 acres

Number of proposed lots: 7 lots

Smallest lot area: 17,671 square feet

Site Zoning: C-2H Commercial

#### **STREETS:**

Common driveways are proposed for use in Phase 2 following the same design used in Phase 1. Lots 5-8 will be accessed from a 40' easement with 24' of paved common drive area. Lots 9-11 will be accessed from a 24' easement with 24' of paved common drive area. Individual driveways will be constructed for lots 6, 7, and 10 starting at the end of the paved area of the common drives. The Subdivision Ordinance allows the use of common drive if the Planning Board determines, and the Board of Commissioners concurs, that the common drive will not endanger or diminish public safety and welfare. The Planning Board reviewed this proposed division at their November 8, 2021 meeting and voted to recommend approval of the preliminary plat with a determination that the common drive would not diminish or endanger public safety and welfare. Any motion by the Board to approve the preliminary plat should include similar language. The Subdivision Ordinance does grant the County the ability to require an access easement (frontage road area) for four or more lots. However, the design of the common drives accomplishes the same objective of a frontage access easement – the decrease in the number of driveway cuts on NC 12. The continued use of the common drives in Phase 2 seems reasonable. The Subdivision Ordinance requires the common drive to be constructed according to the NCDOT pavement requirements. None of the lots will have direct access from NC 12. The covenants for the subdivision will include appropriate language about the use and maintenance of the common drives. "No Parking" signs will be installed along the common drive areas. This was a requirement for Phase 1 also. The installation of the common drives to NCDOT standards will be certified by the project engineer at the time of final plat submission.

#### **UTILITIES:**

- 1. Water: Dare County central water system
- 2. Sewer: Individual on-site septic tank/drainfield systems.
- 3. Stormwater: no State permit required but additional information on stormwater will be needed as part of preliminary review. Information on stormwater has been included on the preliminary plat.

#### **STAFF COMMENTS:**

A copy of the plat has been provided to the Fire Marshal.


Construction on the individual lots will be subject to additional zoning review based on the site specifics proposed for each lot. Individual driveways will be constructed to connect to the common drives as depicted on the preliminary plat. The plat meets the technical merits of the Subdivision Ordinance.




RE: Special Use Permit #4-2021 for Cape Hatteras Electric Membership Corporation (CHEMC) for a New Operations Center.


A request for a Special Use Permit (SUP) for an operations center for the Cape Hatteras Electric Membership Corporation has been submitted for review by Quible and Associates on behalf of the power co-op. The proposed facility is located in Buxton, and is identified as parcel 017075000 with Dare County Tax Mapping. The parcel is zoned R-2A and Private and Public Utility Facilities are permitted as a special use.


The applicant is proposing to build 50' x 148'building that will serve as the operation facility and provide office space, conference rooms, a large kitchen, restrooms, and multiple truck bays. The parcel for the proposed operations center is currently vacant. The applicants currently operate a part of their electric utility facilities on the parcel directly adjacent to the east of the proposed site. The parcels to the north and west of the proposed site are residential. The parcel is bordered on the south by a canal. As part of the SUP application the applicant has submitted an appendix b (site plan) that shows the proposed improvements. Some portions of the proposed improvements will be constructed inside the Coastal Area Management Act jurisdiction and will have to adhere to their regulations as well as the Dare County Zoning Ordinance.

The Dare County Planning Board reviewed the proposed SUP at their November 8, 2021 meeting and deemed the conditions reasonable and appropriate. The Dare County Fire Marshal has reviewed the proposed site plan and has indicated that he has no issues with the proposal. A draft SUP and site plan is attached for the board's review, other conditions may be added to the draft SUP if needed as a result of the December 6, 2021 Commissioners review.



**Special Use Permit No.4 --2021** Dare County Sections 22-22.1, 22-53, 22-65 & 22-70.

Application of: Cape Hatteras Electric Corporation

On December 06, 2021 the Dare County Board of Commissioners considered the application of the Petitioner above named which application is on file with the Dare County Planning Department, and the Board finds as follows:

- 1. That the written application of Petitioner with attachments has been duly submitted to the Dare County Planning Board as required by Section 22 of the Dare County Code (hereinafter referred to as "Code");
- 2. That the application substantially complies with the requirements of the Code in that it requests uses permitted by special use permit under the Code, fish house and dockage facilities;
- 3. The subject property is zoned R-2A. This property is identified on the Dare County tax records as parcel 017075000 and located in the Buxton tax district.
- 4. The Dare County Planning Board reviewed this Special Use Permit at their November 08, 2021 meeting and deemed the conditions reasonable and appropriate.
- 5. That the Dare County Board of Commissioners is empowered under sections of the Code set out above to grant uses such as allowed herein and insofar as the special use is hereinafter allowed it will not adversely affect the public interest;
- 6. That the hereinafter described special use is deemed to be reasonable and is not in degradation of the intent of the ordinance.
- 7. That upon the evidence received, the testimony presented, and the submitted written record, there are sufficient facts to support the issuance of this Special Use Permit according to the terms and conditions below:

NOW, THEREFORE, under the provisions of the Code, the following special use is granted to Cape Hatteras Electric Membership Corporation for a Private Utilities Operations Center subject to such conditions as are hereinafter set out:

**SPECIAL USE:** Private Utilities Operation Center. A site plan depicting the proposed improvements identified as Appendix B is included as part of this Permit.

## **CONDITIONS:**

- 1. There shall be one 7,400 square feet building constructed and used for an operations center for the Cape Hatteras Electric Membership Corporation.
- 2. All necessary Coastal Area Management Act Permits shall be obtained before any development occurs on the parcel.
- 3. Building Permits shall be obtained from the Dare County Planning and Building Department before any construction begins on the proposed structure.
- 4. All building permits shall be obtained within 36 months from the date of approval of this permit.
- 5. All gravel parking, driveways, and drive isles shall be placed on the parcel so that it meets NCDOT and emergency vehicle load requirements. All parking shall meet the requirements of Chapter 22-53 of the Dare County Zoning Ordinance.
- 6. All light fixtures shall be installed so that no light illuminates or reflects on any adjacent property or public right-of-way
- 7. Chain link security fencing shall be installed and maintained along all property lines; those property lines directly adjacent to a residential use shall have opaque chain link fence privacy slats installed.
- 8. No parking or staging of trucks or equipment shall take place in the Right of Way along Light Plant Road.
- 9. The Planning Department staff shall monitor the site. The applicant shall be notified in writing if any violation of this SUP. Appropriate measures to correct any violation identified by the Dare County Planning Department shall be made upon receipt of notice. Failure to correct any violations may void this SUP and may result in the assessments of civil penalties as provided for in Chapter 10 of the Dare County Code of Ordinance and/or any other legal remedy available to Dare County.
- 10. All other terms and provisions of the Dare County Zoning Ordinance shall remain in full force and effect except as herein specifically permitted otherwise;

A Request to close a portion of Beacon Rd in Rodanthe

## Description

Daniel Kerlakian is requesting that the unimproved eastern terminus and cul-de-sac portion of Beacon Road in Rodanthe be permanently closed pursuant to the requirements of North Carolina General Statute 153A-241. Attorney David Dixon is representing Mr. Kerlakian.

Adopt a resolution as required by G.S. 153A-241 to schedule a Public Hearing on the matter on January 3, 2022.

#### § 153A-241. Closing public roads or easements.

A county may permanently close any public road or any easement within the county and not within a city, except public roads or easements for public roads under the control and supervision of the Department of Transportation. The board of commissioners shall first adopt a resolution declaring its intent to close the public road or easement and calling a public hearing on the question. The board shall cause a notice of the public hearing reasonably calculated to give full and fair disclosure of the proposed closing to be published once a week for three successive weeks before the hearing, a copy of the resolution to be sent by registered or certified mail to each owner as shown on the county tax records of property adjoining the public road or easement who did not join in the request to have the road or easement closed, and a notice of the closing and public hearing to be prominently posted in at least two places along the road or easement. At the hearing the board shall hear all interested persons who appear with respect to whether the closing would be detrimental to the public interest or to any individual property rights. If, after the hearing, the board of commissioners is satisfied that closing the public road or easement is not contrary to the public interest and (in the case of a road) that no individual owning property in the vicinity of the road or in the subdivision in which it is located would thereby be deprived of reasonable means of ingress and egress to his property, the board may adopt an order closing the road or easement. A certified copy of the order (or judgment of the court) shall be filed in the office of the register of deeds of the county.

Any person aggrieved by the closing of a public road or an easement may appeal the board of commissioners' order to the appropriate division of the General Court of Justice within 30 days after the day the order is adopted. The court shall hear the matter de novo and has jurisdiction to try the issues arising and to order the road or easement closed upon proper findings of fact by the trier of fact.

No cause of action founded upon the invalidity of a proceeding taken in closing a public road or an easement may be asserted except in an action or proceeding begun within 30 days after the day the order is adopted.

Upon the closing of a public road or an easement pursuant to this section, all right, title, and interest in the right-of-way is vested in those persons owning lots or parcels of land adjacent to the road or easement, and the title of each adjoining landowner, for the width of his abutting land, extends to the center line of the public road or easement. However, the right, title or interest vested in an adjoining landowner by this paragraph remains subject to any public utility use or facility located on, over, or under the road or easement immediately before its closing, until the landowner or any successor thereto pays to the utility involved the reasonable cost of removing and relocating the facility. #### Applicability of NCGS § 153A-241

Per North Carolina General Statutes (NCGS) § 153A-241, a "county may permanently close any public road or any easement within the county and not within a city, except public roads or easements for public roads under the control and supervision of the Department of Transportation" via a board of commissioner's resolution declaring its intent to close the public road or easement and calling a public hearing on the question after providing three weeks' notice.

§ 153A-238(a) pertains specifically to Article 12 defining "public road" or "road" to mean "any road, street, highway, thoroughfare, or other way of passage that has been irrevocably dedicated to the public or in which the public has acquired rights by prescription, without regard to whether it is open for travel...." Per a 1994 Advisory Opinion from the North Carolina Attorney General, "The recording of a plat with roads designated as "public" constitutes an irrevocable offer of dedication to the public..." (*Mr. Leon M. Killian, III, NCAG 1994*). A recent North Carolina Appeals Court decision barring a surfer from using a subdivision's access easement in Duck highlights this point; In *Hovey v. Sand Dollar Shores Homeowners Association, Inc.*, the plat map read, "the streets and roads in this subdivision are dedicated to public use," but did not specifically identify the walkway/easement in question as dedicated to public use. The court found that the road was public but the easement was not.

The dedication on the Southern Vista plat map (enclosed) reads, "The streets and roads in this subdivision are dedicated to public use." The plat map was accepted via signature and recorded by the County Clerk of Dare County. Unlike other subdivisions in the area, the plat map specifically states that the roads are dedicated to public use. For example, the plat map for the subdivision Rodanthe By The Sea states, "the streets on this plat are private streets." Other subdivisions in the area either have "private" written on the streets or dedicate the streets to "public or private use, as noted." Here, there is no ambiguity as to the dedication of E. Beacon Road for public use and thus § 153A-241 applies.

#### **Closure Requirements**

NCGS § 153A-241 further states, "If, after the hearing, the board of commissioners is satisfied that closing the public road or easement is not contrary to the public interest and (in the case of a road) that no individual owning property in the vicinity of the road or in the subdivision in which it is located would thereby be deprived of reasonable means of ingress and egress to his property, the board may adopt an order closing the road or easement.

#### Closure Not Contrary to Public Interest

The easternmost portion of E. Beacon doglegs north and over time as the beach has eroded it has become covered with sandy beach and dunes. This portion of Beacon has been historically used by the public for beach access in addition to parking for renters and homeowners of 23292 (Lot7), 23298 (Lot 6) and at one point the home just to the north (Lot 5) that is now a vacant lot

and precluded from development due to CAMA regulations. Additionally, this section of beach (north of Rodanthe Pier) is not a designated off road vehicle route per the official National Park Service map (enclosed).

Due to beach erosion over time, these homes have consistently had separated septic systems during mild to moderate ocean over wash events. The closure of this portion of Beacon Road would provide for additional space for these systems to be moved further west up the beach, as there is significant space between the property lines and vegetated sand dunes. Having these homes more operable would not only provide more revenue to the County, but would also greatly reduce the environmental health hazards associated with regularly separated septic systems. Both of these benefits are in the best interest of the public.

Furthermore, closing the road would not be detrimental to the public interest as it would have no impact on the public's right to use the beach. Established law in North Carolina is the right to public access over the wet and dry sand beach is a public trust right. The public would still be able to access the beach from E. Beacon. Additionally, no off road vehicles are permitted on this section of the beach and thus closing the road would not impact off road traffic.

#### Closure Will Not Deprive Neighbors of Reasonable Means of Ingress and Egress

Petitioners own two of the five lots at the end of E. Beacon. The southernmost adjacent lot to this portion of road in question (23288 E. Beacon) is technically not part of the Southern Vista subdivision but has an existing easement on to Beacon Road. Access will not be impacted. The two lots north of Lot 6, are vacant land without the possibility of development per CAMA regulations. Lot 5 is identified as Vacant Lot (Private) and lot 4 as a Wash Out.

An access easement to Lots 5 and 4 could be made a condition to the road closure. Although it is clear that these lots will not be practically impacted due to the fact that the lots are vacant and unable to be developed, and no vehicle access is permitted on the portion of land at issue and the area is currently accessible by anyone as public trust land, granting an access easement will ensure that the road closure meets the ingress and egress requirement of the statute.

#### **Result of Closure**

Last, § 153A-241 indicates, "upon the closing of a public road or an easement pursuant to this section, all right, title, and interest in the right-of-way is vested in those persons owning lots or parcels of land adjacent to the road or easement, and the title of each adjoining landowner, for the width of his abutting land, extends to the center line of the public road or easement."

If after the hearing, the Board moves to close the road, the properties adjacent to that portion of the road would take title to the property extending out to the center line of the road. Because this is a curved portion of road with a cul-de-sac, there is some ambiguity as to how the new property lines would be drawn. It would be appropriate to respectfully suggest that the Board of County Commissioners delegate approval of the final property lines to be handled administratively by the director of the Dare County Planning Department. The commissioners may also consider giving the director discretion in regard to the size and placement of an easement to the owners of lots 4 and 5.

Bids for the Avon nourishment and Buxton renourishment project were received on Wednesday, 17 November 2021. **Three** (3) bid packages, submitted from Great Lakes Dredge & Dock Company (GLDD), Manson Construction Company (Manson), and Weeks Marine (Weeks), were opened and read aloud at 2 p.m. in the County's administration office.

We evaluated the bids by the construction cost of the maximum permitted work (ie – 1 million cubic yards for the Avon nourishment project; 1.2 million cubic yards for the Buxton renourishment project; and 2.2 million cubic yards for the combined project). Bids for two construction windows were required: <u>Bid A (2022 construction)</u> and <u>Bid B (2023 construction)</u>. The cost of each bid was compared with the County's reserved construction budget of **\$11,700,000 for Avon, \$18,287,000 for Buxton, and a total of \$29,987,000 million for the combined Avon and Buxton projects.** These funds are a combination of the County's reserved construction budget, the North Carolina Coast Storm Damage Mitigation Fund of \$1,577,607 for Buxton, and FEMA restoration funds of \$8,835,528 for Buxton.

The apparent low bids for both Bid A (2022 construction) and Bid B (2023 construction) were submitted by GLDD. Bid A and Bid B are lower than the County's reserved budget for nourishment; furthermore, Bid A is approximately <u>7 percent lower</u> than Bid B.

In summary, the bid price to complete the maximum permitted work in 2022 yields **a total of \$4,117,000 in savings for the County.** The apparent low bids for Bid A and Bid B are summarized in Table 1.

# **BID EVALUATION**

#### 1) Bid A (2022 Construction):

As requested, all three bidders submitted bids for Bid A. The total price to complete the maximum permitted work (ie – 1 million cubic yards for Avon; 1.2 million cubic yards for Buxton; and 2.2 million cubic yards for the combined project) proposed by the three companies, <u>from the lowest to the highest</u>, are summarized in Table 2.

The bid prices in Table 2 include the cost of mobilization and demobilization, dredging, placement, grading, and environmental protection as required under federal and state permits. The lowest bid to complete the maximum permitted volume (2.2 million cubic yards) was submitted by GLDD, and it is \$3,180,000 lower (~11% lower) than the second-lowest bid submitted by Weeks. The lowest bid is \$19,630,000 lower (~43% lower) than the third bid submitted by Manson. GLDD and Weeks have dredges of comparable size and are expected to provide competitive bids within 10–20% of each other. Manson has a smaller fleet with dredges smaller in size and capacity than GLDD and Weeks, and it would take longer for Mason to complete a project of this scale. Manson was the highest bidder for the recent "Four-Town" renourishment project (bid opening on 2 Sept 2021) and the Nags Head FEMA renourishment project (bid opening on 7 October 2021). Nevertheless, Manson attended the mandatory pre-bid meeting and provided the third bid, enabling the bid opening to be conducted on schedule according to North Carolina statutes.

#### 2) Bid B (2023 Construction):

As requested, all three bidders submitted bids for Bid B. The total price to complete the maximum permitted work (ie – 1 million cubic yards for Avon; 1.2 million cubic yards for Buxton; and 2.2 million cubic yards for the combined project) proposed by the three companies, <u>from the lowest to the highest</u>, are summarized in Table 3.

Similar to Table 2, the bid prices in Table 3 include the cost of mobilization and demobilization, dredging, placement, grading, and environmental protection as required under federal and state permits. The lowest bid to complete the maximum permitted volume (2.2 million cubic yards) was submitted by GLDD, and it is only \$400,000 (~1.4%) higher than the second-lowest bid submitted by Weeks. Manson's bid to complete work in 2023 is lower than for 2022 but is still ~\$9 million higher (over 30% higher) than the bids by GLDD and Weeks.

# ANALYSIS OF RECENT BEACH NOURISHMENT MARKET


Each nourishment project involves different logistical and operational constraints, and it is difficult to compare those itemized costs directly. For example, some projects could have a lower mobilization and demobilization cost but a higher sand placement cost, or vise versa. An equivalent unit price (ie – the total price divided by the nourishment yardage) is generally a more reliable index to use to compare project pricing. Table 4 lists the equivalent unit price for the recent bids received for projects in similar settings and nature since 2016. All projects in this table used (or will use) offshore borrow areas. Results are also plotted in Figure 1.


The equivalent unit price for the Avon nourishment project is ~10.07 per cy (/cy). Avon received the lowest unit price since the 2018 Nags Head renourishment bid by piggy-backing with the Buxton renourishment project. The unit price for the Buxton renourishment project is ~13.17/cy, which is 3.10/cy higher than the Avon project but 4.40/cy lower than the Nags Head FEMA project. Due to the challenging location of the Buxton area, this price is very favorable for the County.

Considering the Avon nourishment and the Buxton renourishment as one project, the equivalent unit price is ~\$11.76/cy. This price is slightly higher than the price received for the "Four-Town" renourishment project (~\$11.10/cy) and is significant lower (\$5.81/cy lower) than the Nags Head FEMA project. In conclusion, the bid price for the Avon nourishment and Buxton renourishment project is highly favorable to the County under current dredging market conditions.

# **RECOMMENDATION FOR AWARD**

GLDD provided the lowest bid for Bid A (2022 construction) and would be able to complete 100% of the maximum permitted volume (ie – 1 million cubic yards for Avon and 1.2 million cubic yards for Buxton). The total bid price is not only within the reserved budgets for construction for Avon and Buxton, but also it will yield a total of over 4 million dollars in savings for the County.

GLDD is America's largest dredging contractor and a major international competitor. They have accomplished numerous beach nourishment projects throughout the US coast. GLDD was the contractor that successfully completed the 2011 Nags Head nourishment project (4.6 million cubic yards), the 2017 "Four-Town" nourishment project (~4 million cubic yards), and the 2019 Nags Head renourishment project (4 million cubic yards) in Dare County. They have the largest fleet of ocean-certified dredges in the United States and has identified two hopper dredges for the Avon and Buxton project. The *Liberty Island* completed over 50% of the 2011 Nags Head nourishment project and over 55% of the 2019 Nags Head renourishment project. The other dredge proposed for the Avon and Buxton project is *Ellis Island*, America's largest dredge with 2.5 times the maximum capacity of the *Liberty Island*. We believe the two hopper dredges can accomplish the work within the time frame (**May 1st to September 15<sup>th</sup>, 2022**) proposed by GLDD under Bid A.

CSE has worked with GLDD on projects at Seabrook Island (SC, 1990), Pine Knoll Shores & Indian Beach (NC, 2001), Edisto Beach & Hunting Island (SC, 2006), Emerald Isle, Pine Knoll Shores & Indian Beach (NC, 2007), Nags Head (NC, 2011), Southampton (NY, 2013–2014), Isle of Palms (SC, 2018), Arcadian Shores (SC, 2019), Nags Head (NC, 2019), and Hunting Island (SC, 2020). With extensive experience, two available hopper dredges, and a bid ~11% lower than the second-lowest bid, GLDD is clearly the Apparent Low Bidder. **CSE recommends GLDD be issued the Notice of Award to complete the project in 2022.** 

The County received the NC State CAMA permits on 10 November 2021 and the NPS Special Use Permits on 12 November 2021. The USACE permit is pending final approval. <u>Benthic monitoring is required</u> by both the CAMA and NPS permits for the pre- and post-project conditions. CSE recommends the County reserve funds for benthic monitoring. CSE will coordinate with qualified contractors and obtain a cost estimate for the County's approval.

Once the County makes a decision and awards the work, CSE will coordinate with the Contractor, NPS, state and federal resource agencies, and the County to determine an "Order of Work" before construction.

At 5:01 p.m. Chairman Woodard called to order the regularly scheduled meeting with appropriate prior public notice having been given. He invited George Lurie to share a prayer, and then he led the Pledge of Allegiance to the flag.

## ITEM 1 – OPENING REMARKS – CHAIRMAN'S UPDATE

Following is a brief outline of the items mentioned by Chairman Woodard during his opening remarks, may be viewed in their entirety in a video on the Dare County website:

- Chairman provided an update on Dare County 20/21 graduates. There were 409 graduates last year and twenty-five percent (103) had enrolled to attend COA. Four percent were going to work, one percent joined the military and the rest were furthering their education.
- He attended the funeral of Della Basnight and touched on her theater and television career.
- Manteo High School boys' soccer team, the Redskins, was advancing to the state soccer 2A Regional Championship after winning over Clinton High School.
- He commended the towns for their Veterans Day celebrations in Southern Shores, Manteo, Nags Head and Kill Devil Hills.

Chairman Woodard outlined the many accomplishments and contributions of Nancy Griffin, who had recently retired from public service. She had worked in Dare schools for twenty-nine years and with a number of the community's nonprofit organizations. He presented her with a certificate of appreciation from the county. The presentation was done via a video conferencing connection and may be viewed on the Dare County website.

Commissioned in 1989, it was originally a 50,000 gallon plant and had been upgraded to support 340,000 gallons daily. He was would report back to the Board at their next meeting.

The County Manager closed Public Comments at 5:37 p.m.

# ITEM 3– PUBLIC HEARING – RICHARD FERTIG – REQUESTED AMENDMENT DEFINITION OF HOTEL/MOTEL

At 5:38 p.m. the Board held a Public Hearing to receive input concerning this agenda item. Mr. Outten outlined the procedure for making public comments in Manteo and via the video link to the Fessenden Center Annex in Buxton. No one responded to the invitation to address the Board of Commissioners on this issue. Public Hearing was closed at 5:38 p.m.

- <u>Board of Equalization and Review</u> Commissioner House motioned to reappoint Nelson V. Jones, Jonathan Waddill, Jeffrey Scott, Terry Gore and Charles Evans. Vice-Chairman Overman seconded the motion. VOTE: AYES unanimous
- Special Motor Vehicle Valuation Review Board Commissioner House motioned to reappoint Danny Couch, Dock Sawyer and David Light to another term. Commissioner Bateman seconded the motion. VOTE: AYES unanimous

#### By consensus, the Board agreed to handle <u>Item 8 - Closed Session</u> after <u>Item 9 -</u> <u>Commissioners' Business & Manager's/Attorney's Business</u> had been concluded.

# **ITEM 8 - CLOSED SESSION**

Chairman Woodard asked for a Closed Session pursuant to NCGS 143-318.11(a)(6) to review the qualifications, competence, performance, character and fitness of an individual public officer or employee and pursuant to NCGS 143-318.11(a)(3) to consult with an attorney in order to preserve the attorney-client privilege, receive an update on the opioid litigation and to approve the minutes of the last Closed Session.

## MOTION

Commissioner Tobin motioned to go into Closed Session pursuant to the provisions of the North Carolina General Statutes cited by the Chairman. Commissioner House seconded the motion. VOTE: AYES unanimous

At 6:52 p.m., the Commissioners exited the room to meet in Closed Session. They reconvened at 8:00 p.m. and the County Manager reported that during the Closed Session the Board had been advised and accepted the national opioid settlement.

## **MOTION**

Vice-Chairman Overman motioned to accept the national opioid settlement and authorized the County Manager/Attorney to sign any settlement documents, as necessary.

Commissioners Bateman and Tobin seconded the motion. VOTE: AYES unanimous.

The County Manager advised the Board had also approved previous Closed Session Minutes

## ITEM 9 – COMMISSIONERS' BUSINESS & MANAGER'S/ATTORNEY'S BUSINESS

The Commissioners and the County Manager frequently make extensive remarks, which may be viewed in their entirety on the Dare County website. The following is a brief summary of the items mentioned by Commissioners during this segment:

#### Commissioner Bateman

- He applauded the presentations to both Nancy Griffin and Virginia Tillett. They had each contributed so much to the County.
- He commented Commissioner House would be presenting a resolution to oppose the proposed changes in North Carolina shrimp fisheries management plan. He generally purchased 30,000 pounds of shrimp each year for his restaurant. If the changes to the plan were accepted, it would devastate families, businesses and the entire economy on the Outer Banks. This week he had received several contacts from foreign vendors selling shrimp. He offered the restrictions and changes were un-American and needed to be strongly opposed. The majority of the crab meat coming into the country currently came from China and he does not serve crab cakes in his restaurant for that reason.

#### Vice-Chairman Overman

- He had worked closely with Nancy Griffin primarily through the Saving Lives Task Force and among her many talents was the creation of articles and the quarterly newsletter. She had worked tirelessly for the kids of Dare County and they were always her first interest.
- He had worked with Virginia Tillett on a few projects over the years and in particular commented on her exceptional coordination to refurbish the rest area at North End Park.
- He had been attending some of the NC Marine Fisheries' meetings since 2013. He stated the shrimp issue was an ongoing problem and if we lose the ability to feed ourselves, we would be "in deep stuff". He felt the resolution would be an important part. If a letter was needed from the Board to press the point, it needed to be done.

## Commissioner Tobin

- He had been a commercial fisherman for fifteen years and agreed with previous commissioner comments on how the shrimping industry would be impacted and possibly destroyed with the proposed changes.
- Updated the Board on construction of the dredge. It was still on schedule. There would be
  a change order due to the increased price of steel. The survey boat was contested by the
  state as not being part of the project. There would be a line being added to legislation by
  the end of the year regarding inclusion of the survey boat so it could be included in
  financing of the project.
- Remembered the passing of his good friend, Steve D. Howell. He had been retired as a top Brame representative and had sold products to many of the local businesses.

## Commissioner Ross

He gave an update on the Albemarle Commission's budget. It had grown to just over \$9
million due to federal grant money and would have plenty of resources to provide aid
citizens with many services such as meals on wheels, congregate meal programs, job
counseling and workforce development.

- He would be attending the 5 on 5 Committee meeting this week to continue discussions with school board senior staff regarding Dare County schools.
- There would be an Audit Committee meeting scheduled in the coming weeks.
- He thanked Donna Creef on her explanations regarding the multi-family development proposed in Avon. The Board had met earlier today and continued to push hard for progress and resolution that will result in action on housing needs in Dare County.
- He stated Dare County was lucky to have citizens like Virginia Tillett and Nancy Griffin who had contributed much and focused on area needs.
- Reinforced the Board's need to push and pursue the alleviation of roadblocks confronting the volunteers of the Joint Community Advisory Committee in to order insure the proper and best care for our seniors and elderly.

#### **Commissioner House**

- Commented Nancy Griffin was a remarkable woman and deserving of recognition.
- Remembered Virginia Tillett as someone who instantly became great friends with everyone she met.
- He presented the Board with a Resolution Opposing Any Changes to NC Shrimp Fisheries Management Plan. Every five years the plan is reviewed for changes. Scoping on the plan had been opened January 7-21, 2020. There had been three scoping meetings in Washington, Morehead City and Wilmington. The County Manager read a resolution to oppose the changes proposed by Amendment 2 to the NC Shrimp Fisheries Management Plan. (Att. #3)

#### MOTION

Commissioner House motioned to adopt the Resolution Opposing Any Changes to the North Carolina Shrimp Fisheries Management Plan.

Vice-Chairman Overman and Commissioner Bateman seconded the motion. VOTE: AYES unanimous

Chairman Woodard stated a letter signed by each member of the Board could potentially emphasize the County's opposition to the proposed changes. The Board agreed to craft such a letter and have it sent to each member of the NC Marine Fisheries Commission tomorrow.

- Today in history: The Articles of Confederation were adopted by Congress on November 15, 1777. This seldom recognized document established the functions of the United States government and was often used to settle territorial issues.
- The Pet of the Week video was presented and showcased a dog named Skippy.

## MANAGER'S/ATTORNEY'S BUSINESS

County Manager Outten summarized the grant funding for emergency management for raising housing in the flood plain. There were two approved programs, one where FEMA paid for 100% of the raising and the other where the property owner bore the 25% of the expense. Some of the 25% matches were substantial (\$50-\$75,000+) and the Planning Director was sending notification to those owners regarding the status of the grants. The matching funds from property owners would need to be received by the County in order to sign the grant and move forward.

The County Manager recapped the discussion of the Board's Special Housing Workshop. The Elizabethan Inn would not be compatible for conversion into affordable housing. Consultants were running some new numbers based on new parameters and the Board would be able to review options and make decisions at the December Board meeting that would allow solicitation of housing developers for potential projects after the first of the year.

He and Mr. Clawson had met in Edenton earlier in the day. In 2010, when Albemarle Mental Health had dissolved, the liability of healthcare for the retired employees had been picked up by the member counties. In 2010, approximately \$800,000 had been placed into a trust account for health insurance costs. There was \$300,000 left, which was calculated to be inadequate for the expected lives of the seventeen retirees. There would be a need to put money in the fund and Dare County's share would be approximately \$172,000. It was the consensus of the counties to place one fifth of each share into the trust beginning July, 2022.

The county engineer, Albemarle Engineering, had been engaged to create a county storm water plan. The preliminary results of the plan included the culverting of water flow from Airport Road through two subdivisions and connecting to the ditch behind the airport, EOC and the animal shelter. Survey work would be needed and was estimated at \$200,000. American Rescue Plan funds could be used for part of the expense. The state's budget, if approved, may also have storm water funds to curb the cost.

He stated the Kinnakeet Shores wastewater treatment plant had not been maintained and there a sewer moratorium had been issued, which prevents owners of vacant lots in the area from developing homes. He had contacted the NC Division of Water Quality and the Utilities Commission and there was nothing further that the county could do to facilitate the lifting of the moratorium.

Dave Clawson reported that the debt for the Manteo Masonic Lodge and Mako Mikes purchases would close next Monday. As to beach nourishment, the LGC had changed their deadline to November 19<sup>,</sup> 2021. Dare County had a draft of the audit report and would submit the final on Friday. Mr. Outten added the county still needed a permit which was held up by the nationwide pause on 401 water quality permits. Dare County was waiting for the local Corps to release the permit in time. He had spoken with the delegation in DC and their response has been they are doing everything to "dislodge" the pause. The Buxton/Avon beach nourishment bid would be opening November 17, 2021.

Chairman Woodard reported he had gone to Avon last week after the storm with the County Manager and there were surprisingly only eight-ten breaches north of the pier along the roadway. They had actually seen much worse on N.C. 12 and applauded the speed and efficiency of the reparation done by NCDOT.

At the conclusion of the meeting, Chairman Woodard asked for a motion to adjourn. **MOTION** 

Commissioner House motioned to adjourn the meeting. Commissioner Ross seconded the motion. VOTE: AYES unanimous

- I. <u>Background</u>: No change.
- II. <u>Purpose</u>:

This Agreement Addendum revision #1 enables the Local Health Department to purchase fentanyl test strips per the updated federal guidance.<sup>31</sup> In addition, this Revision increases the funding amount to allow for expansion of services due to the dramatic spike in drug overdose deaths over the last year.<sup>32</sup>

#### III. <u>Scope of Work and Deliverables</u>:

As of November 1, 2021, this Agreement Addendum Revision #1 adds Paragraphs 5 and 6, as follows:

5. Revisit planned programmatic activities to ensure the overdose prevention and harm reduction strategies are meeting the needs of the service population: Perform written or verbal participant surveys to ensure that services are meeting the needs appropriately given the overlapping overdose epidemic and COVID-19 pandemic. All survey results should be compiled and analyzed, and services shall be adjusted accordingly.

      - d) Expand comprehensive support programs within the SSP, such as harm reductionbased support groups, peer navigation to identify participant needs and enroll in local services accordingly, and other methods to ensure connection to appropriate care services.
    - 2) Expand the SSP referral network for additional social determinants of health resources:
      - a) Increase referrals to a variety of communicable disease testing and treatment services including COVID-19 testing, and hepatitis and HIV testing and treatment services. (Section VI, Paragraph 2 states what funds may not be used for, including that funds may not be used to support the purchasing of any medications or direct medical service.)
      - b) Connect participants to COVID-19 vaccination opportunities.

  - c. **Expansion of post-overdose response teams (PORT)** led by Emergency Medical Services (EMS) and/or a community-based organizations with experience working with people directly impacted by drug use to prevent repeat overdose and connect those who have had a non-fatal

overdose to harm reduction, social and health services, treatment and recovery supports, including housing or employment. The following list of expansion activities are supported in this Agreement Addendum:

- 1) Increase PORT staff, peers/outreach workers, administrative personnel, case managers, and other roles time spent to support program services and operations.
- 2) Purchase eligible harm reduction, wound care and social determinants of health supplies, such as biohazard disposal containers, safer use supplies, alcohol swabs, gauze, bandages, hygiene products, barrier methods for sexual health, bags, food, and temporary housing supplies such as tents and sleeping bags (but <u>not</u> medications, syringes, hypodermic needles, or cookers).
- 3) Expand outreach or service delivery hours of operation to reach addition PORT participants.
- 4) Expand the PORT referral network for additional social determinants of health resources:
  - a) Increase referrals to a variety of communicable disease testing and treatment services including COVID-19 testing, and hepatitis and HIV testing and treatment services.
  - b) Connect participants to COVID-19 vaccination opportunities.
  - c) Increase connections to SSPs, substance use disorder treatment providers, housing, transportation, employment, recovery, and other related care services.

#### VI. <u>Funding Guidelines or Restrictions</u>:

As of November 1, 2021, this Agreement Addendum Revision #1 makes the following changes:

Under the paragraph indicating <u>what the funds may not be used for</u>, replaces Paragraph 2.a. with the following:

a. Syringes, hypodermic needles, cookers, or medications including naloxone. For the period June 1 through October 31, 2021 only, funds may not be used to purchase fentanyl test strips.

# Under the paragraph indicating <u>what the funds may be used for</u>, replaces Paragraph 3.f. with the following:

f. Syringe services program care supplies, such as alcohol swabs, gauze, band aids, hygiene products, bags, and food. Other forms of drug checking supplies or tools, such as mass spectrometers, for the purpose of harm reduction and overdose prevention are allowed. As of November 1, 2021, fentanyl test strips are also allowed.

## III. <u>Scope of Work and Deliverables</u>:

## All of the activities the Local Health Department performs under this Agreement Addendum shall be informed by the NC DHHS COVID-19 Guidance for Health Care Providers and local health departments.<sup>1</sup>

For each of the six activities listed below (Paragraphs 1 through 6), the Local Health Department (LHD) shall identify and address one or more of the allowable activities listed, with an emphasis on testing and tracing:

## 1. Enhance Laboratory, Surveillance, Informatics and other Workforce Capacity

- a. Build expertise for healthcare and community outbreak response and infection prevention and control (IPC) among local health departments.
- b. Train and hire staff to improve the capacities of the epidemiology and informatics workforce to effectively conduct surveillance and response of COVID-19 (including contact tracing) and other conditions of public health significance.
- c. Build expertise to support management of the COVID-19 related activities within the jurisdiction (e.g., additional leadership, program and project managers, budget staff).
- d. Increase capacity for timely data management, analysis, and reporting for COVID-19 and other conditions of public health significance.

## 2. Strengthen Community Laboratory Testing

- a. Establish or expand capacity to quickly, accurately and safely test for SARS-CoV-2 among all symptomatic individuals, and secondarily expand capacity to achieve community-based surveillance, including testing of asymptomatic individuals.
  - 1) Strengthen ability to quickly scale testing as necessary to ensure that optimal utilization of existing and new testing platforms can be supported to help meet increases in testing demand in a timely manner.
  - 2) Build local capacity for testing of SARS-CoV-2 including within high-risk settings or in vulnerable populations that reside in their communities.
- b. Enhance laboratory testing capacity for SARS-CoV-2 outside of public health laboratories.
  - 1) Establish or expand capacity to coordinate with public/private laboratory testing providers, including those that assist with surge and with testing for high-risk environments.

- 2) Secure and/or utilize mobile laboratory units, or other methods to provide point-of-care (POC) testing at public health-led clinics or non-traditional test sites (e.g., homeless shelters, food processing plants, prisons, Long Term Care Facilities [LTCFs]).
- c. Enhance data management and analytic capacity in public health laboratories to help improve efficiencies in operations, management, testing, and data sharing.
  - 1) Improve efficiencies in laboratory operations and management using data from throughput, staffing, billing, supplies, and orders.
  - 2) Improve the capacity to analyze laboratory data to help understand and make informed decisions about issues such as gaps in testing and community mitigation efforts. Data elements such as tests ordered and completed (including by device/platform), rates of positivity, source of samples, type will be used to create data visualizations that will be shared with the public, state health department, and community partners.

## 3. Advance Electronic Data Exchange at Public Health Labs

- a. Enhance and expand laboratory information infrastructure, to improve jurisdictional visibility on laboratory data (tests performed) from all testing sites and enable faster and more complete data exchange and reporting.
  - 1) Enhance laboratory test ordering and reporting capability.
    - a) 100% of results must be reported with key demographic variables including age/gender/race via NCCOVID.
    - b) Report all testing to the state health department using NCCOVID.

## 4. Improve Surveillance and Reporting of Electronic Health Data

- a. Use NCCOVID to ensure complete, up-to-date, automated reporting of morbidity and mortality to NC DPH of COVID-19 and other conditions of public health significance by:
  - 1) Establishing or enhancing community-based surveillance, including surveillance of vulnerable populations, individuals without severe illness, those with recent travel to high-risk locations, or who are contacts to known cases.
  - 2) Monitoring changes to daily incidence rates of COVID-19 and other conditions of public health significance at the county or zip code level to inform community mitigation strategies.
- b. Establish complete, up-to-date, timely, automated reporting of individual-level data through electronic case reporting to NC DPH via NCCOVID
  - At the health department, enhance capacity to work with testing facilities to onboard and improve electronic laboratory reporting (ELR), including to receive data from new or non-traditional testing settings. Use alternative data flows and file formats (e.g., CSV or XLS) to help automate where appropriate. In addition to other reportable results, this should include all COVID-19/SARS-CoV-2-related testing data (i.e., tests to detect SAR-CoV-2 including serology testing).
  - 2) Assist NC DPH in the process of automating the receiving of electronic health record (EHR) data, including electronic case reporting (eCR) and fast healthcare interoperability resources (FHIR)-based eCR to generate initial case reports as specified by NC DPH for the reportable disease within 24 hours and to update over time within 24 hours of a change in information contained in the CDC-directed case report, including death.
  - 3) Utilize eCR data to ensure data completeness, establish comprehensive morbidity and mortality surveillance, and help monitor the health of the community and inform decisions for the delivery of public health services.

- c. Improve understanding of capacity, resources, and patient impact at healthcare facilities through electronic reporting.
  - Assist NC DPH with required expansion of reporting facility capacity, resources, and patient impact information, such as patients admitted and hospitalized, in an electronic, machine-readable, as well as human-readable visual, and tabular manner, to achieve 100% coverage in jurisdiction and include daily data from all acute care, long-term care, and ambulatory care settings. Use these data to monitor facilities with confirmed cases of COVID-19/SARS-CoV-2 infection or with COVID-like illness among staff or residents and facilities at high risk of acquiring COVID-19/SARS-CoV-2 cases and COVID-like illness among staff or residents.
- d. Enhance systems for flexible data collection, reporting, analysis, and visualization.
  - 1) Make data on case, syndromic, laboratory tests, hospitalization, and healthcare capacity available on health department websites at the county/zip code level in a visual and tabular manner.
- e. Establish or improve systems to ensure complete, accurate and immediate (within 24 hours) data transmission to NCCOVID and open website available to the public by county and zip code, that allows for automated transmission of data to NC DPH via NCCOVID.
  - 1) Track via NC DETECT 100% of emergency department and outpatient visits for COVID-like illness, as well as other syndromes/illnesses, to CDC.
  - 2) Submit all case reports in an immediate, automated way to CDC for COVID-19/SARS-CoV-2 and other conditions of public health significance with associated required data fields via NCCOVID.
  - 3) Provide accurate accounting of COVID-19/SARS-CoV-2 associated deaths. Establish electronic, automated, immediate death reporting to CDC with associated required data fields via NCCOVID.
  - Report requested COVID-19/SARS-CoV-2-related data, including line level testing data (negatives, positives, indeterminants, serology, antigen, nucleic acid) daily by county or zip code to NCCOVID.
  - 5) Establish these systems in such a manner that they may be used on an ongoing basis for surveillance of, and reporting on, other threats to the public health and conditions of public health significance.
- f. Integrate existing LHD electronic health records (EHR) into CVMS Direct.

CVMS is the COVID-19 Vaccine Management System; CVMS Direct is an integration solution offering for Providers to connect COVID-19 vaccination records with CVMS. Providers submit a standardized flat file from their Electronic Health Records (EHRs) that pass through the Health Information Exchange (HIE) and are loaded directly to CVMS. This NC COVID-19 Vaccine Reporting file (NCVR) contains patient information that complies with today's CVMS workflow across patient registration and vaccination recording, along with appropriate inventory reduction.

Before the LHD can use the CVMS Direct integration solution, the LHD will need to finalize legal agreements with the HIE, establish connectivity, complete file validations, and pass testing criteria before they can use the CVMS Direct integration. The North Carolina Health Information Exchange Authority (NC HIEA) is responsible for CVMS Direct. Any local health department interested in using CVMS Direct will need to contact NC HIEA at hiea@nc.gov.

## 5. Use Laboratory Data to Enhance Investigation, Response and Prevention

a. Use laboratory data to initiate case investigations, conduct contact tracing and follow-up, and implement containment measures.

- 1) Conduct necessary contact tracing including contact elicitation/identification, contact notification, and contact follow-up. Activities could include traditional contact tracing and/or proximity/location- based methods, as well as methods adapted for healthcare-specific and congregate settings.
- 2) Utilize tools (e.g., geographic information systems and methods) that assist in the rapid mapping and tracking of disease cases for timely and effective epidemic monitoring and response, incorporating laboratory testing results and other data sources.
- 3) Identify cases and exposure to COVID-19 in high-risk settings or within vulnerable populations to target mitigation strategies.
  - a) Assess and monitor infections in healthcare workers across the healthcare spectrum.
  - b) Monitor cases and exposure to COVID-19 to identify need for targeted mitigation strategies to isolate and prevent further spread within high-risk healthcare facilities (e.g., hospitals, dialysis clinics, cancer clinics, nursing homes, and other LTCFs).
  - c) Monitor cases and exposure to COVID-19 to identify need for targeted mitigation strategies to isolate and prevent further spread within high-risk employment settings (e.g., meat processing facilities), congregate living settings (e.g., prisons, youth homes, shelters), and educational settings (e.g., K-12 schools, colleges and universities).
  - d) Work with NC DPH to build local capacity for reporting, rapid containment and prevention of COVID-19/SARS-CoV-2 within high-risk settings or in vulnerable populations that reside in their communities.
- b. Implement prevention strategies in high-risk settings or within vulnerable populations (including tribal nations) including proactive monitoring for asymptomatic case detection and increasing opportunities for vaccination of historically marginalized populations and the community. Continue working collaboratively with partners including consideration of funding to address health equity needs of the community. Examples of partners may include but are not limited to:
  - 1) Tribal affiliates and community-based organizations colleges and universities;
  - 2) Occupational health settings for large employers;
  - 3) Churches or religious or faith-based institutions;
  - 4) Federally Qualified Health Centers (FQHCs), including Community Health Centers (CHCs);
  - 5) Pharmacies;
  - 6) Long-term care facilities (LTCFs), including independent living facilities, assisted living centers, and nursing homes;
  - 7) Organizations and businesses that employ critical workforce;
  - 8) First responder organizations;
  - 9) Non-traditional providers and locations that serve high-risk populations; and other partners that serve underserved populations.
- c. Build capacity for infection prevention and control in LTCFs (e.g., at least one Infection Preventionist [IP] for every facility) and outpatient settings.
  - 1) Build capacity to safely house and isolate infected and exposed residents of LTCFs and other congregate settings.
  - 2) Develop interoperable patient safety information exchange systems.
- d. Assist with enrollment of all LTCFs into NHSN.

- e. Increase Infection Prevention and Control (IPC) assessment capacity onsite using tele-ICAR.
- f. Perform preparedness assessment to ensure interventions are in place to protect high-risk populations.
  - 1) Coordinate as appropriate with federally funded entities responsible for providing health services to vulnerable populations (e.g., tribal nations and federally qualified health centers).

## 6. Coordinate and Engage with Partners

- a. Partner with NC DPH to establish or enhance testing for COVID-19/SARS-CoV-2.
  - 1) Acquire equipment and staffing to conduct testing for COVID-19/SARS-CoV-2.
  - 2) Support community partners to conduct appropriate specimen collection and/or testing within their jurisdictions.
- b. Partner with local, regional, or national organizations or academic institutions to enhance capacity for infection control and prevention of COVID-19/SARS-CoV-2.
  - 1) Build infection prevention and control and healthcare outbreak response expertise in the LHD.
  - 2) Partner with academic medical centers and schools of public health to develop regional centers for IPC consultation and support services.

## IV. <u>Performance Measures/Reporting Requirements:</u>

## 1. Performance Measures

- a. **Performance Measure # 1:** The LHD shall have a COVID-19 Testing Plan to ensure access to COVID-19 testing for all symptomatic persons and for those who have had close contact to a known or suspected case of COVID-19 as defined by the CDC, and for those who request or require testing.
- b. **Performance Measure # 2:** Via the NCCOVID, the LHD shall report cases of COVID-19 including deaths within 30 days of receipt of the report to the state disease registrar.
- c. **Performance Measure # 3**: Via the outbreak module within NCCOVID and the REDCap cluster/outbreak reporting tool, the LHD shall report COVID-19 activity (decline, no change, and increase) in high-risk healthcare facilities (e.g., nursing homes, dialysis centers, LTCFs) and congregate living settings (e.g., prisons, youth homes, shelters) within 2 days of receiving notification of an outbreak/cluster.
- d. **Performance Measure #4**: Using the COVID-19 Community Team Outreach (CCTO) Tool software, the LHD shall report close contacts to COVID-19 for at least 50% of people infected with COVID-19.
- e. **Performance Measure #5:** Using the COVID-19 Community Team Outreach (CCTO) Tool software, the LHD shall complete the Final Monitoring Outcome variable for 90% of contacts entered after 14 days.

## 2. Reporting Requirements

The reporting below shall be provided by the LHD to DPH via the Smartsheet dashboard, which can be accessed at https://app.smartsheet.com/b/publish?EQBCT=2a6fdcc2c5da4b39834c3a154e4916cd.

a. The LHD shall complete a **Monthly Financial Report** each month via the Smartsheet dashboard. These monthly financial reports will report on the prior month, with the due dates posted on the Smartsheet dashboard. The first financial report is to report for June 2021 and is due by July 22, 2021.

- b. The LHD shall complete a **Program Report** each quarter via the Smartsheet dashboard. These quarterly program reports will report on the prior quarter, with the due dates posted on the Smartsheet dashboard. The first program report is to report for April June 2021 and is due by July 22, 2021. The quarterly periods for these program reports are defined as:
  - April June 2021 \*
  - July September 2021
  - October December 2021
  - January March 2022

\*April and May 2021 data are from services provided under the Agreement Addendum for state fiscal year 2021.

c. The LHD shall complete a **COVID-19 Response Plan** via the Smartsheet dashboard. This response plan is to provide information related to the LHD's broader goals and partnerships for COVID-19 preparedness and response. The Smartsheet dashboard will present a series of questions to be answered in a short-answer format, with topics including aspects of testing, contact tracing, vaccination, equity, and preparedness in general. Information about the LHD's COVID-19 Testing Plan will be another topic contained within the COVID-19 Response Plan, and completing the COVID-19 Response Plan will fulfill the requirement listed above in Performance Measure #1.

The LHD will be providing responses for a <u>single</u> COVID-19 Response Plan and this plan will meet the reporting requirements described under the FY22 Agreement Addenda for this Activity 543 and for Activity 716.

The COVID-19 Response Plan will receive DPH oversight from the DPH Branch staff members representing each relevant aspect. Any questions the LHD has should be directed to the DPH Division Director's Office at <u>lhdhealthserviceta@dhhs.nc.gov</u>.

DPH will add the **COVID-19 Response Plan questionnaire** to the Smartsheet dashboard by August 31, 2021. The LHD shall provide its responses no later than September 30, 2021.

#### V. <u>Performance Monitoring and Quality Assurance:</u>

- 1. The TATP Nurse Supervisor will review the Local Health Department's program performance through reporting done quarterly by the LHD and by a quarterly review of reports pulled from the NCCOVID, the REDCap cluster/outbreak reporting tool, and the CCTO tool.
- 2. If the assessment results in compliance concerns, the TATP Nurse Supervisor shall conduct conference calls with the Local Health Department to provide technical assistance in order to rectify the concerns.

### VI. <u>Funding Guidelines or Restrictions</u>:

- 1. Requirements for pass-through entities: In compliance with 2 CFR §200.331 Requirements for pass-through entities, the Division of Public Health provides Federal Award Reporting Supplements to the Local Health Department receiving federally funded Agreement Addenda.
  - a. Definition: A Supplement discloses the required elements of a single federal award. Supplements address elements of federal funding sources only; state funding elements will not be included in the Supplement. Agreement Addenda (AAs) funded by more than one federal award will receive a disclosure Supplement for each federal award.
  - b. Frequency: Supplements will be generated as the Division of Public Health receives information for federal grants. Supplements will be issued to the Local Health Department throughout the state fiscal year. For federally funded AAs, Supplements will accompany the original AA. If AAs are revised and if the revision affects federal funds, the AA Revisions will include Supplements. Supplements can also be sent to the Local Health Department even if no change is

needed to the AA. In those instances, the Supplements will be sent to provide newly received federal grant information for funds already allocated in the existing AA.

- 2. As the LHD is a subrecipient of a grant or cooperative agreement awarded by the Department of Health and Human Services (HHS) with funds made available under the Coronavirus Preparedness and Response Supplemental Appropriations Act, 2020 (P.L. 116-123); the Coronavirus Aid, Relief, and Economic Security Act, 2020 (the "CARES Act") (P.L. 116-136); and/or the Paycheck Protection Program and Health Care Enhancement Act (P.L. 116-139) the LHD agrees as applicable to the award, to:
  - a. comply with existing and/or future directives and guidance from the HHS Secretary regarding control of the spread of COVID-19;
  - b. in consultation and coordination with HHS, provide, commensurate with the condition of the individual, COVID-19 patient care regardless of the individual's home jurisdiction and/or appropriate public health measures (e.g., social distancing, home isolation); and
  - c. assist the United States Government in the implementation and enforcement of federal orders related to quarantine and isolation. In addition, to the extent applicable, Recipient will comply with Section 18115 of the CARES Act, with respect to the reporting to the HHS Secretary of results of tests intended to detect SARS-CoV-2 or to diagnose a possible case of COVID-19. Such reporting shall be in accordance with guidance and direction from HHS and/or CDC.
  - d. consistent with the full scope of applicable grant regulations (45 C.F.R. 75.322), the purpose of this award, and the underlying funding, the subrecipient is expected to provide to CDC, through DPH, copies of and/or access to COVID-19 data collected with these funds, including but not limited to data related to COVID-19 testing. CDC will specify in further guidance and directives what is encompassed by this requirement.
- 3. In addition to their local procurement rules/policies, the LHD shall comply with the following rules, applying the most restrictive standard where there is a difference between any of the standards:

- 4. Unallowable costs:
  - a. Research
  - b. Clinical Care
  - c. Publicity and propaganda (lobbying):
    - 1) Other than for normal and recognized executive-legislative relationships, no funds may be used for:
      - a) publicity or propaganda purposes, for the preparation, distribution, or use of any material designed to support or defeat the enactment of legislation before any legislative body
      - b) the salary or expenses of any grant or contract recipient, or agent acting for such recipient, related to any activity designed to influence the enactment of legislation, appropriations, regulation, administrative action, or Executive order proposed or pending before any legislative body
