22-58.6 ACCESSORY DWELLING UNITS

A public hearing on a request to amend Section 22-58.6 and associated zoning districts of the Dare County Zoning Ordinance is scheduled for April 20, 2022. In January 2022 the Dare County Board of Commissioners directed the planning board and planning staff to revisit the ADU ordinance and draft new language that would extend the ADU regulations to districts that are zoned single family residential specifically R-1 Residential and East Lake Natural Historic zoning districts in an attempt to build housing stock to help with the housing crisis.

The Planning Board reviewed this request at their February and March meetings. On March 14, 2022 the Planning Board voted to recommend approval of the request. The Planning Board found the amendments to be consistent with the land use plan. Any favorable action by the Board of Commissioners must also include a finding of consistency and reasonableness. A statement of this finding is included with my staff report, along with the draft conditions.

### **Draft motions:**

Motion to adopt: "I move the draft amendments to Section 22-58.6 and associated zoning district be adopted as drafted. A statement of consistency and reasonableness as prepared by staff is adopted as part of this motion."

Motion to revise: I move the draft amendments to Section 22-58.6 and associated zoning districts to address (insert revised language). A statement of consistency and reasonableness as prepared by staff is adopted as part of this motion."

No motion is needed if the Board chooses to take no action on the proposed amendments. Failure to take no action on the proposed regulation or amendment shall be deemed a denial of the proposed regulation or amendment unless stated otherwise by the Board of Commissioners.



### STATEMENT OF CONSISTENCY AND REASONABLENESS

On April 20, 2022, the Dare County Board of Commissioners considered a zoning text amendment to Section 22-58.6 (Accessory Dwelling Units) and associated zoning districts of Dare County Zoning Ordinance to expand Accessory Dwelling Units to the R-1 Residential and East Lake Natural Historic Zoning Districts. These amendments seek to makes changes to the zoning regulations to address the housing needs of Dare County.

The Dare County Planning Board reviewed the proposed amendments on March 14, 2022 and voted to recommend favorable action on the amendment.

Section 22-86 of the Dare County Zoning Ordinance requires the Board of Commissioners to approve a statement of consistency and reasonableness for any proposed zoning amendment.

The 2009 Dare County Land Use Plan is the comprehensive plan for unincorporated Dare County adopted by the Dare County Board of Commissioners on December 6, 2010.

A review of the Dare County Land Use Plan found the following policies to be applicable to the zoning text amendment:

### Land Use Compatibility Management Topic

### Policy LUC #4

To address the housing needs of the year-round population, multi-family dwellings and other types of residential structures, such as accessory use dwellings, are considered appropriate alternatives when located in areas zoned for multi-family structures and constructed on lots or parcels greater than the minimum lot size for single family lots established in the individual zoning districts of the Dare County Zoning Ordinance. This diversification of housing opportunities is important to address the needs of Dare County's workforce.

Based upon a review of the policy, the Dare County Board of Commissioners finds the zoning amendments to be consistent with the 2009 Dare County Land Use Plan since the amendments will facilitate the potential for an increase in the number of available year-round housing units. These amendments will help address the current housing crisis in Dare County.

## SECTION 22-58.6 - ACCESSORY DWELLING UNITS (proposed amendments are in bold and italicized)

An accessory dwelling unit (ADU) may be located on a residential lot in the following zoning districts:

Hatteras Island: *R-1*, R-2, R-2A, R-2H, R2-AH C-2, C2-H, C-3, I-1, S-1

Colington/KDH Outside: R-1, R-2, R2-B, VC-2, C-3

Manteo Outside: R-1, RS-6, RS-8, R-2, R-3, C-3, I-1, SNC

Wanchese: WR-1, VR, BT, RB, NC MLM, WVC, MC-1, MC-2, and Highway 345

Manns Harbor: MH-A, MH-B

East Lake: ELR, ELVC, ELCS, ELNH

The following standards shall apply to all ADUs except for those districts in Wanchese and East Lake which have ADU standards included as part of the district regulations.

- 1. Only one ADU may be permitted per lot in conjunction with a principal dwelling unit. The residential lot may contain other accessory structures as authorized by the applicable zoning district. The construction of an ADU on a lot does not constitute a group housing development as established in Section 22-31 of the Dare County Zoning Ordinance.
- 2. An ADU may be attached to a primary dwelling unit or may be a detached separate structure. An ADU shall not exceed 50% of the floor area of the primary use structure or a maximum of 1200 square feet of heated and non-heated space unless the applicable zoning district for the lot establishes a different ADU maximum size limitation. The size limitation shall not apply if existing floor area within a primary dwelling unit is internally remodeled or existing interior space is converted for use as an ADU.
- 3. Lot coverage Lot coverage may be increased for the footprint area of an ADU but in no instance shall lot coverage exceed 38% to accommodate the construction of an ADU unless the applicable zoning district for the lot establishes a different ADU lot coverage limitation. No increase in lot coverage is authorized for those ADUs that are located within the interior of an existing structure. This increase in lot coverage is for the ADU structure and shall not be used for other structures or impervious coverages. If existing lot coverage of the property exceeds 38%, then reductions in lot coverage shall be made in order to accommodate the ADU.
- 4. Two 10' x 20' parking spaces shall be provided on the residential lot outside of any dedicated right-of-way or access easement. Parking shall be of permeable surfaces as allowed for single family dwellings in Section 22-56 of the Dare County Zoning Ordinance. The location of the ADU parking shall be approved by the Dare County Planning Department during the permit review process. Existing parking may be used if excess parking for the primary dwelling unit is available.

- 5. Any ADU shall be constructed according to NC State building codes and Dare County floodplain management regulations.
- 6. Recreational vehicles, travel trailers and/or manufactured homes shall not be used or approved as an ADU.
- 7. An ADU shall be located on a residential lot according to the applicable principal dwelling use setbacks. An existing accessory structure may be converted to an ADU if compliance with the principal dwelling setbacks, ADU size limitation, and applicable Dare County floodplain management regulations can be met. Any ADU shall be constructed to be complaint with the building height of the applicable zoning district.
- 8. Any ADU approved under these guidelines shall be used for long-term occupancy as defined in Section <u>22-2</u> of the Zoning Ordinance. Any ADU approved under these guidelines shall not be used for commercial or business activity. However, this limitation shall not prevent the ADU from being authorized as a home occupation according to the definition in Section <u>22-2</u>.
- 9. An ADU shall not be subdivided or segregated in ownership from the principal dwelling unit. (Adopted 10-15-2018)

The following standards shall apply to ADUs only located in the R-1 zoning districts.

1. Any ADU constructed in the R-1 shall be accessed from a state maintained road, private road, publicly dedicated road, and/or a 20' easement.

## SECTION 22-21 - R-1 LOW DENSITY RESIDENTIAL DISTRICT (proposed amendments are in bold and italicized)

The following regulations shall apply to the R-1 low-density residential district:

- **(a) Intent.** The R-1 district is intended to encourage the development of permanent low-density residential neighborhoods. These districts are located primarily in areas susceptible to environmental damage from more intensive uses of the land.
  - **(b) Permitted uses.** The following uses shall be permitted by right:
    - (1) Detached single-family dwellings, not to include mobile homes.
- **(2)** Customary accessory buildings, including private swimming pools and tennis courts.
  - (3) County owned or leased facilities.
- (4) Accessory dwelling unit according to the provisions of Section 22-58.6 of this code.

## SECTION 22-16.3 - EAST LAKE NATURAL HISTORIC DISTRICT (ELNH) (proposed amendments are in bold and italicized)

- (a) Scope and intent. The East Lake Natural Historic district is established to provide for the protection and enhancement of those areas within the County which are significant as places of natural beauty or are areas with local or national historical significance. It is the intent of this chapter to encourage reasonable public and private uses and development within these areas.
  - **(b) Permitted uses.** The following uses shall be permitted by right:
    - (1) Detached single-family dwellings, not to include mobile homes.
- (2) Customary accessory buildings, including private swimming pools and tennis courts.
- (3) Churches and cemeteries. This shall also include other associated church facilities including recreational structures, childcare facilities, and overnight lodging.
  - (4) Museums.
- **(5)** Wildlife refuges, game preserves, botanical gardens and natural preservation areas.
  - (6) Historic sites.
  - (7) State and natural parks.
  - (8) County owned or leased facilities.
- (9) Accessory dwelling unit associated with principal residential use subject to compliance with all supplementary local, state, and federal permit approvals and in addition to the following:
- a. An accessory dwelling unit may be attached to the principal residence or may be detached from the principal residence. The size of an accessory dwelling unit, whether attached or detached from the principal residence, shall not exceed 900 square feet of heated space.
- b. An accessory dwelling unit, whether attached to or detached from the principal residence, shall be located on the site in conformance with the building setbacks of this zoning district.
  - c. One additional off-street parking space shall be required.
- d. Travel trailers and recreational vehicles shall not be used as accessory dwelling units.
- e. Accessory dwelling units may be used for home occupations as defined Section 22-2 of the Dare County Zoning Ordinance.

Another issue that has increased in frequency of complaints since the 2003 LUP update is the issue of junked and abandoned vehicles. The County Code of Ordinances includes a junked and abandoned vehicle ordinance that is outdated and extremely cumbersome to enforce. The issue is complicated by the lack of a storage yard available for the relocation of junked and/or abandoned vehicles once removed from private property. In larger metropolitan areas, local governments often own and maintain vehicle yards for the storage of junked vehicles. This is not the case in Dare County where County owned lands are dedicated to other uses such as schools, office buildings, and infrastructure needs. The vehicle storage yards are often the source of contaminants in stormwater which is another concern. As Dare County continues to grow and become more developed, updating the County's junked and/abandoned vehicle ordinance to include alternatives to the traditional removal and mass storage may be needed.

### Policy LUC #3

Residential structures shall be the preferred land use in unincorporated Dare County for both seasonal accommodations and permanent housing. All new residential structures, whether attached or detached, are encouraged to be on a scale that is consistent with existing neighborhood patterns of development.

### Implementation Strategy:

 Administration of existing regulations of the Dare County Zoning Ordinance for minimum lot size, dwelling density, building height and other standards for residential development. Changes in wastewater technology, improved construction practices for "green" buildings, market conditions, and demographic trends should be examined periodically to ensure that the standards of the Dare County Zoning Ordinance are not obsolete and recognize newer technologies that may benefit our existing communities. (2010-2015).

### Policy LUC #4

To address the housing needs of the year-round population, multi-family dwellings and other types of residential structures such as accessory use dwellings, are considered appropriate alternatives when located in areas zoned for multi-family structures and constructed on lots or parcels greater than the minimum lot size for single family lots established in the individual zoning districts of the Dare County Zoning Ordinance. This diversification of housing opportunities is important to address the needs of Dare County's workforce.

### Implementation Strategy:

1. Administration of Family Housing Incentive Standards (section 22-58.2) of the Dare County Zoning Ordinance to address workforce housing needs. (2010-2015)

Shallow Draft Application for Miss Katie- Oregon Inlet Dredging

Traditionally, funds for dredging in Oregon Inlet were transferred to the U.S. Army Corps of Engineers via the Long-Term MOA. This process involved Dare County submitting the County share to the North Carolina Division of Water Resources, which would then add their matching share from the Shallow Draft Navigation Fund, and transfer to the Corps.

However, with the Miss Katie coming online this summer, the process will be altered. The State will continue to provide funds from the Shallow Draft Navigation Fund, but Dare County is required to submit a Shallow Draft Navigation Fund application. As with other projects in which we have utilized this grant, the State will provide funds on a reimbursement basis.

Grants & Waterways is requesting the Board of Commissioners authorize the submission of the grant application and adopt the Resolution to Sponsor the Miss Katie – Oregon Inlet Dredging Project. If awarded, the State will cost share up to \$6,000,000 (66%) and Dare County will provide up to \$3,000,000 (33%) in matching funds. Dare County will utilize the Oregon Inlet Maintenance account for the required matching funds.



## Resolution to Sponsor the Miss Katie – Oregon Inlet Dredging Project

**WHEREAS**, Dare County desires to sponsor the Miss Katie - Oregon Inlet Dredging Project to provide funding for dredging in Oregon Inlet and nearby channels.

### THEREFORE, BE IT RESOLVED THAT:

- 1) Dare County requests the State of North Carolina provide financial assistance to Dare County for the Miss Katie Oregon Inlet Dredging Project in the amount of \$6,000,000 or 66.67% of project cost, whichever is the lesser amount;
- 2) Dare County assumes full obligation for payment of the balance of project costs;
- 3) Dare County will obtain all necessary State and Federal permits;
- 4) Dare County will comply with all applicable laws governing the award of contracts and the expenditure of public funds by local governments;
- 5) Dare County will supervise construction of the project to assure compliance with permit conditions and to assure safe and proper construction according to approved plans and specifications;
- 6) Dare County will obtain appropriate easements, rights-of-way or suitable dredge material disposal areas that may be necessary for the construction and operation of the project without cost or obligation to the State;
- 7) Dare County will ensure that the project is open for use by the public on an equal basis with limited restrictions, if on public property;
- 8) Dare County will hold the State harmless from any damages that may result from the construction, operation and maintenance of the project;
- 9) Dare County accepts responsibility for the operation and maintenance of the completed project.



At 8:32 a.m. Chairman Woodard called to order the special meeting with appropriate prior public notice having been given. He invited Commissioner Couch to share a prayer and then he led the Pledge of Allegiance to the flag.

A complete account of the Board's discussion on this item is archived and available for viewing on the website referred to above. Synopsis follows:

Mr. Outten presented to the Board that the County's health plan was due to renew today with open enrollment next week. Elizabeth Reilly, Human Resources Director, addressed the Board and explained there were currently two plans offered to employees. One has a high deductible and is paired with a HSA (health savings account) and the other is a traditional PPO with co-pays and deductibles. The first change was to increase the payment into the Health Savings Account. Currently the HAS for each employee with the plan is \$750 and it is proposed to change that to \$1,500.00. The second proposed change would be a reduction in the co-pays for the PPO plan. It is currently \$50 for copay and \$100 for a specialist. The change would be \$25/50. The final change would be in the tiers offered for employees. Currently there were (a) employee only 100% paid by county (b) employee with children (no spouse) and (c) employee with family (spouse and children). The fourth tier to be added would be for an employee and a spouse (no children). Most organizations currently have four tiers. The Board discussed and commented the changes to add a fourth tier was typical in the industry. Commissioner Tobin asked for confirmation that the three changes did not change the budgeted funds for the county's policies and Mr. Outten agreed. Chairman Woodard noted the insurance plan had worked well over the past several years. Mr. Outten

agreed the addition of the Wellness Clinic, the creation of the HSA and other efforts had come together and helped stabilize the plan. Commissioner Couch asked if the insurance program offered by Dare was competitive with other localities and Mrs. Reilly said the tiers and copay changes would do just that.

### **MOTION**

Commissioner House motioned to approve the renewal of the health plan with the three proposed changes.

Commissioner Tobin seconded the motion.

VOTE: AYES unanimous.

At the conclusion of the meeting, Chairman Woodard adjourned the meeting at 8:52 a.m. until 9:00 a.m., April 4, 2022.



### ITEM 1 - OPENING REMARKS - CHAIRMAN'S UPDATE

Following is a brief outline of the items mentioned by Chairman Woodard:

- April 8, at 2:00 p.m., would be the College of the Albemarle new facility ribbon cutting. He read the many degree and program certificate offerings by the new community college.

### ITEM 2 - PRESENTATION OF COUNTY SERVICE PINS

Charles Lycett, Emily Cunningham, Ronnie Gibbs and Stephen Baum received their 10-year pins. Betsy Robinson and Cara Basnight received their 20-year pins. Kenneth Randall and Gregory Padilla received their 25-year pins. There was a total of 130 years of service between the eight Dare employees.

### ITEM 3 – EMPLOYEE OF THE MONTH – April 2022

Employee of the Month was awarded to Willie Spencer by Chuck Lycett, who described the many ways that he serves with excellence as a custodian in the Social Services Department. Mr. Spencer was always looking for ways to lend a hand and was not afraid to take on new projects to make everything in the department look better.

### ITEM 4 - PUBLIC COMMENTS

At 9:41 a.m. the Manager outlined the procedure for making public comments in Manteo and via the video link to the Fessenden Center Annex in Buxton. Following is a summary:

The following comments were made in Manteo

 Chuck Still, new Executive Director for the Roanoke Island Historical Association, introduced himself to the Board. He emphasized the seriousness with which he took on the responsibilities of producing The Lost Colony drama. Rehearsals would begin April 25 with a revamped production to begin Memorial Day. He also encouraged everyone to attend the 2022 Lost Colony Wine Festival.

No comments from Buxton. The County Manager closed Public Comments at 9:45 a.m.

ITEM 5 – SEA GLASS COTTAGES LLC – SPECIAL USE PERMIT APPLICATION #1-2022 After all parties to this proceeding were duly sworn, Planning Director, Noah Gillam outlined a Special Use Permit (SUP) application from Sea Glass Cottages, LLC. The cluster home group development would consist of eight dwellings on 27242 Sand Street in Salvo. There was a 900 sq. ft. dwelling to be relocated off the site. The zoning ordinance required the development dwellings be occupied on a long-term basis (longer than 31 days). The Fire Marshal had reviewed the site plan and required residential sprinkler systems in each home. Conditions had been added that the Dare County Planning Board found to be reasonable for the applied use. Mr. Outten advised the Board that Chris Hemschot had emailed and voiced a request for a continuance of the application. The County Manager asked the applicant, Gary Lake, of Sea Glass Cottages, LLC, if he agreed to the admission into evidence of the material submitted and on file in the Planning Department, the facts presented, and the terms and conditions outlined in the SUP. Mr. Lake indicated his agreement.

#### MOTION

Commissioner Bateman motioned to approve the SUP #1-2022 and associated site plan for the proposed cluster home group development as presented.

Commissioner Couch seconded the motion.

**VOTE: AYES unanimous** 

### ITEM 6 - TRILLIUM HEALTH RESOURCES - ANNUAL REPORT

Dave Peterson, Trillium Health Resources, Central Regional Director, presented his annual report. See presentation via Dare County website at www.darenc.com.

## ITEM 7 – ZONING AMENDMENT TO ALLOW FOR THE EXPANSION OF ACCESSORY DWELLING UNITS (Att. #1)

Noah Gillam, Planning Director, presented the Board with drafted new language that would extend the Accessory Dwelling Unit regulations to districts that were zoned single family residential. He requested a public hearing be set for April 20, 2022, as required for the new language to be adopted by the Board.

#### MOTION

Vice-Chairman Overman motioned to set a public hearing for April 20, 2022 at 5:00 p.m. Commissioner Bateman seconded the motion.

VOTE: AYES unanimous.

## ITEM 8 – OUTER BANKS NATIONAL SCENIC BYWAY FRISCO-BUXTON PATHWAY COMMITTEE (Att. #2)

Mary Helen Goodloe-Murphy and Laura Ertle described the overall project which would be 7.6 miles of 5' wide pathway in the NC12 right of way. The pathway would run from the National Park Service's Frisco Bathhouse to the Valero gas station in Buxton. The Committee asked for a resolution endorsing a request to the General Assembly for a referendum creating a special tax district to construct and maintain the pathway. The district would include 1607 taxable properties in Frisco and 897 properties in Buxton. The one cent tax could provide \$62,200 annually. It would cost \$10,000 just to maintain mowing. The construction estimate was \$3.5 million. The grant would help build 4.41 miles of the pathway. Mr. Outten stated if the legislature gave authority to create the district, the Board would still have to authorize the imposition of the tax. One issue of needed maintenance was where new driveways were installed and the thickness of the driveway and walkway did not match.

### **MOTION**

Commissioner House motioned to adopt the resolution as presented.

Commissioner Tobin seconded the motion.

VOTE: AYES unanimous.

# ITEM 9 – OUTER BANKS NATIONAL SCENIC BYWAY FRISCO-BUXTON PATHWAY COMMITTEE – NATIONAL SCENIC BYWAY GRANT FOR BUILDING PATHWAY IN FRISCO AND BUXTON

Laura Ertle went through the specifics of the grant being applied for to construct the pathway. The state deadline for filing was April 20 and the national program deadline was May 16, 2022. They would like to submit one application for two phases of the project or 4.41 miles of the pathway. They sought a 20% match for the \$2 million needed, which would be \$200,000. NCDOT will be the applicant and Dare County would be the financier. It was a reimbursable grant. They requested Chairman Woodard to provide a letter to the Tourism Board requesting support for a long term unappropriated grant. Mr. Outten asked who would put up the funds for reimbursement. Mary Helen said it was a federal aid grant and Dare County would fund the first \$2 million, which would be reimbursed. Mr. Clawson indicated no budget issues as long as funds were reimbursed.

### **MOTION**

Commissioner Tobin motioned to submit a Letter of Intent with necessary changes as mentioned to grant application for a National Scenic Byway Program grant, authorize the County Manager to sign said application and agree for the Chairman to send a request for matching funds to the Dare County Tourism Board.

Commissioner House seconded the motion.

VOTE: AYES unanimous.

### ITEM 10 - DHHS/SOCIAL SERVICES: CHILD SUPPORT RFP FROM YOUNGWILLIAMS

Chuck Lycett advised YoungWilliams had responded to the RFP to handle child support payment enforcement. Commissioner House the renewal terminology clarified. The contract could be renewed for an additional three years. At the end of eight years, the YoungWilliams contract would be brought back to the Board for any other renewal options.

#### **MOTION**

Commissioner Ross motioned to accept the bid and authorize the County Manager, or his designee, to proceed with a 5-year contract with the option to renew for 3 years. Commissioner House seconded the motion.

VOTE: AYES unanimous.

### At 10:50 a.m. Commissioner Ross left the meeting room and returned at 10:54 a.m.

### ITEM 11 – SOUTH FERRY CHANNEL CORRIDOR EXPANSION PROJECT (Att. #3)

Barton Grover advised South Ferry channel was again shoaled in with limited 2-3 feet passage. The Corps had identified a corridor which was partially in our permitted area. In order to allow for the USACE to dredge this area, a new cultural resources survey and permit modification would be necessary. Grants and Waterways requested authorization to submit a DEQ grant application which could provide up to 75% of total costs. The County's match would come from the Grants and Waterways' budget. Vice-Chairman Overman asked if the sand could be used by Hyde County, as there was a real need at the northern end. Mr. Grover said that would not be easy with the Merritt or Murden, but there was a lot of Corps money and perhaps an upcoming pipeline project which could include Hyde County. The Corps was currently working on permitting. Mr. Outten indicated he had recently spoken with Superintendent Hallac and discussed possible sand sources. Ocracoke would be an easier area for sand deposit than the bird islands. It would be a good idea and provide beneficial impact to widen the northern portion of Ocracoke.

### **MOTION**

Commissioner Tobin motioned to authorize submission of a NC DEQ Shallow Draft Navigation Fund grant application and adopt the resolution to sponsor the project. Commissioner House seconded the motion.

VOTE: AYES unanimous

### ITEM 12 – RESOLUTION IN SUPPORT OF THE MID-CURRITUCK BRIDGE (Att. #4)

Chairman Woodard presented resolution reaffirming the Board's commitment to the Mid-Currituck Bridge project.


