Resolution Concerning the Use of Plastic Straws.docx

Resolution Concerning the Use of Plastic Straws

Whereas, Americans use 500 million straws everyday in America alone, and according to the Washington Post straws are non-recyclable materials and instead degrade into smaller microplastics that are incapable of disappearing completely and settle on the ocean floor or will end up both in landfills, oceans, and the ecosystems; and

Whereas, according to the US Environmental Protection Agency, in 2014 more than 33 million tons of plastic was thrown away in the US; and

Whereas, 71% of seabirds and 30% of sea turtles have been reportedly found with plastic in their stomachs; and

Whereas, according to a report made by the World Economic Forum, by the year 2050 the amount of plastic in the oceans will outweigh the amount of fish; and

Whereas, according to NPR, there are more than 5 trillion particles of plastics in the world's oceans, and according to the B.A.N list, 7% of the plastics found in the environment are straws and coffee stirrers; and

Whereas, bamboo, paper, straw, steel, and glass are all eco-friendly, reusable, and affordable alternatives to plastic straws; and

Whereas, paragraph 160 of the United Methodist Social Principles states, "We support and encourage social policies that serve to... encourage reduction of municipal waste; provide for appropriate recycling and disposal of municipal waste" and "We support regulations that protect and conserve the life and health of animals,"; and

Whereas, Psalms 95:4-5 states "The earth's depths are in his hands; the mountain heights belong to him; the sea, which he made, is his along with the dry ground, which his own hands formed.", and as the earth is the God's, we should strive to maintain it and better it in every way possible, and;

Whereas, the tourism industry is essential to the North Carolina economy, and according to the Department of Commerce, tourism expenditures directly supported 197,690 jobs for North Carolina residents, and pollution from plastics will harm the environment which would hurt the local economy; and

Whereas, New York City, Hawaii, California, Washington, New Jersey, and Florida have all begun the process of legislation regarding the limitation of straws;

Therefore, be it resolved that we, the 67th session of the Annual Conference of the North Carolina Youth of the United Methodist Church support a ban on plastic straws across the state of North Carolina by 2020, and both encourage and implore the NC Legislature and local governments to impose a ban on non-biodegradable plastic straws for use in commercial and domestic capacities; and

Therefore, be it further resolved that this resolution be sent to North Carolina House Speaker Tim Moore, Senator Richard Burr, Senator Thom Tillis, Governor Roy Cooper, Sysco CEO William J. Delaney III, and the County Commissioners of the coastal counties: Brunswick, New Hanover, Pender, Onslow, Carteret, Pamlico, Beaufort, Hyde, Dare, Tyrrell, Washington, Bertie, Chowan, Perquimans, Pasquotank, Camden, and Currituck Counties.



Settlement of Sink v. Dare County

Description

Under North Carolina law, local governments are required to pay a separation allowance until the age of 65 to law enforcement officers who retire early if they meet certain requirements. Deputy Leary Sink retired before age 65 but in our view did not meet the requirements of the statute. He sued the County seeking separation allowance pay retroactive to 2012 and continuing to 2020 when he reaches age 65.

In closed session, the Board gave the County Manager authority to settle within certain limits. A settlement agreement has been reached for \$10,000 which is within the authorized limits. In order to settle, the Board must approve the settlement in open session.

-Public Hearing-- Golf Carts in Buxton

Description

A public hearing is scheduled for 5:30 p.m. on proposed revisions to Chapter 100 of the Dare County Code to allow the operation of golf carts on certain streets in Buxton village. A copy of the draft revisions and list of streets is attached and a map of the streets. Upon the close of the hearing, the Board may choose to adopt the proposed revisions, make amendments to the draft language based on board discussion and/or public input, or may choose to take no action.

Motion to adopt -- "I move to adopt the proposed revisions to Chapter 100 to allow the operation of golf carts in Buxton village only on those streets listed in the draft language."

Chapter 100 STREETS AND SIDEWALKS (proposed language is underlined)

Golf Carts on Streets and Roads in Specified Areas of Unincorporated Dare County.

100.30 Operation of Golf Carts

- a. Golf carts may be operated on all streets and roads in Hatteras village west of and including Austin Road and Austin Lane where the speed limit is 35 mph or less.
- b. Golf carts may be operated on Bayview Drive and First Street in Stumpy Point village where the speed limit is 35 mph or less.
- c. Golf carts may be operated in the Village of Avon on the following streets where the speed limit is 35 mph or less: a) Harbor Road west of North End Road and the streets connected to Harbor Road located west of North End Road; b) the following streets and the streets connected to the following streets: North End Road, McMullen Road, Reef Drive, Old Main Road and Williams Road.
- d. Golf carts may be operated in Waves village in the St. Waves Subdivision on Sea Vista Court and Sea Vista Drive where the speed limit is 35 mph or less.
 - e. Golf carts may be operated in Buxton Village on the following streets where the speed limit is 35 mph or less: Old Lighthouse Road; Cape Point Way, Diamond Shoals Drive, Buxton Back Road, Dippin Vat Road, Cross Way Road, Lost Tree Trail, Rocky Rollinson Rd, Webb Lane, Middle Ridge Trail, Crooked Ridge Trail, and Light Plant Road

100.31 Definitions

A golf cart is defined for the purposes of this subchapter as a vehicle designed and manufactured for operation on a golf course for sporting or recreational purposes and that is not capable of exceeding speeds of 20 miles per hour. (Reference NCGS 20-4.01)

100.32 Age Restriction

No person less than the age of 16 may operate a golf cart on the streets of a specified area as authorized in subsection 100.30.

100.33 Hours of Operation


The operation of golf carts in those areas as specified in Subsection 100.30 shall be lawful during the hours of 7:00 a.m. to 5:00 p.m. eastern standard time and 6:00 a.m to 9:00 p.m. eastern (daylight) savings time until October 1 and from 6:00 a.m. to 8:00 p.m. until the end of eastern (daylight) savings time.

100.34 Method of Operation

All persons operating golf carts as authorized in subsection 100.30 shall do so in a responsible and safe manner and shall obey all traffic safety laws and traffic control signage.

100.35 Violations

Any person operating a golf cart in violation of this subsection shall be guilty of a Class 3 misdemeanor and shall be fined \$50.00 for each violation.



§ 153A-245. Regulation of golf carts on streets, roads, and highways.

- (a) Notwithstanding the provisions of G.S. 20-50 and G.S. 20-54, a county may, by ordinance, regulate the operation of golf carts, as defined in G.S. 20-4.01(12a), on any public street, road, or highway where the speed limit is 35 miles per hour or less within the county that is located in any unincorporated areas of the county or on any property owned or leased by the county.
- (b) By ordinance, a county may require the registration of golf carts, charge a fee for the registration, specify who is authorized to operate golf carts, and specify the required equipment, load limits, and the hours and methods of operation of golf carts. No person less than 16 years of age may operate a golf cart on a public street, road, or highway. (2009-459, s. 1.)

Public Hearing-- Revisions to Chapter 99 Camping

Description

A public hearing on proposed revisions to Chapter 99.15 CAMPING of the Dare County Code is scheduled for the August 20 meeting. These proposed revisions are proposed to remove a conflict between the current language of Chapter 99.15 and language in the Dare County Zoning Ordinance that precludes recreational equipment and vehicles from being used for housekeeping purposes. The draft revisions to Chapter 99 are attached. The current language in Chapter 99 allows persons to live or reside in automobiles, campers or other vehicles. The revisions will still allow property owners and their families to camp on their own property. Following the hearing the Board may choose to adopt the language, make revisions, or choose to take no action. The Planning Board recommended approval on July 9, 2018.

CAMPING (new language is underlined, text for deletion in strikethrough)

Section 99.15 DEFINITIONS

For the purposes of this subchapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

IMMEDIATE FAMILY Father, mother, brother, sister, son, daughter or grandparent.

FAMILY -- Persons related by blood or marriage

NIGHT That period of time each day from 1 hour after sunset until 1 hour before sunrise.

OPEN AIR CAMPING Any act of living, residing or sleeping at night in the open air or in an automobile, other vehicle, a camper or mobile home. The term **CAMPING IN THE OPEN AIR** includes, but is not limited to sleeping out of doors in a tent, sleeping bag, blanket, hammock. or without any paraphernalia other than the clothes worn on the body.

99.16 OPEN AIR CAMPING RESTRICTED

No person shall engage in the act of open air camping within the county, in the unincorporated portions of Dare County, except as follows:

- (A) Open air camping is permitted on private property which is owned by the person engaged in the act of open air camping or by someone in the immediate family of the person engaged in open air camping. This exception applies to all members of the group or party of which the owner or member of the immediate family is a member.
- (B) Any person may engage in the act of open air camping on private property with written permission of the owner of that private property, provided that the written permission signed by the owner, must be exhibited to any peace officer or police officer upon request.



Public Hearing-- Jon Midgett Construction LLC -- CS Zoning Text Amendment

STAFF REPORT - August 20, 2018 Board Meeting

RE: Public Hearing -- CS Text Amendment to allow boat engine repair and

boat maintenance as a permitted use

Last month, the Board scheduled a public hearing on proposed amendments to the CS, commercial services district, to allow small engine repairs / boat repairs and boat engine repairs as a conditional use in the CS district. The amendment has been filed by Elizabeth Robbins on behalf of Jon Midgett Construction LLC. Jon Midgett Construction owns property located at 1145 Colington Rd. A four-unit metal building is under construction on the property. Mr. Midgett has been approached by an operator of a boat engine repair business about purchasing one of the four units.

During the discussion at the Board meeting last month, it was noted by Mrs. Robbins and some of the Board members that the repair of small engines and boat engines is compatible with the other uses currently allowed in the CS district. Emails from the adjoining property owner and resident were received in opposition of the proposed text amendment. They are concerned about noise from the repair of small engines and boat motors. They have received notice of the hearing as required by NC law but as of the date of the report I have not heard from them. The Hills' property is located in the R-2B alternative residential zoning district. Issues the County experienced with another boat engine repair business in Colington were discussed last month. This other business is located in the Village Commercial (VC-2) zoning district and the adjoining residential uses are also zoned VC-2.

The CS district applies to portions of Colington Rd. Its intent statement reads as follows: "to provide a setting for various service establishments that are more intense in their scope of activities than retail/office zoning district but not as intense as those generally found in an industrial setting". Any text amendment to the CS district would apply to all lands zoned CS. Any proposed boat repair business would have to apply for a conditional use permit subject to review by the Planning Board and approval by the Board of Commissioners.

The Planning Board reviewed the Midgett request at their June 11 meeting. After discussing the text amendment, a motion to recommend adoption of the text amendment to add small engine repairs/boat engine repairs and boat repairs as a

conditional use to the CS district failed to pass on a 3-3 vote of the Planning Board members. No alterative motion was offered. Because the motion failed to pass, the Planning Board did not adopt any finding of consistency or finding of inconsistency. The applicable land use plan policy is Policy LUC #5—Dare County encourages the continued existence of and development of locally-owned businesses in unincorporated Dare County. The Midgett request can be considered consistent with this policy.

At the close of the hearing, the Board will have completed all requirements to act on the proposed amendment. If it is the consensus of the Board to act favorable on the proposed amendment, then it might be appropriate to include some specific conditions with the amendment as we have done in the past on other zoning amendments. This would ensure that anyone interested in pursuing site plan approval for such a use was aware of these conditions early in the site plan review process. I have included a list of potential conditions as Exhibit A.

<u>Draft motions for action</u>

Adopt the requested amendment: "I move to amend the CS district to add small engine repairs/boat engine repairs/boat repairs to the list of conditional uses in the CS district." A finding of consistency statement is adopted as part of this motion indicating the proposed amendment is consistent with Policy LUC#5 of the 2009 Dare County Land Use Plan."

Adopt the proposed amendment with revisions to add specific conditions as part of the amended language: "I move to amend the CS district to add small engine repairs/boat engine repairs/boat repairs to the list of conditional uses in the CS district with the specific conditions as outlined in Exhibit A. A finding of consistency statement is adopted as part of this motion indicating the proposed amendment is consistent with Policy LUC#5 of the 2009 Dare County Land Use Plan."

Choose to not adopt the requested amendment. No action on the Board's part is needed if it is the consensus of the Board to not adopt the requested amendment. The CS district will remain unchanged.

EXHIBIT A – Possible Conditions to Add to CS Language

Section 22- 26.1 Commercial Services

- (c) Conditional Uses –
- 4. Small engine repair/ boat repair and maintenance /boat motor repair subject to the following conditions:
- 1. All boat trailers, boat motors, and boats shall be stored or parked inside of a designated fenced area to be identified during the site plan review process. The identified storage/parking area shall be enclosed with solid fencing, 10 feet in height. The fencing may be comprised of two sections of fence material to reach the 10 feet of total height. The fencing shall be designed and certified by the North Carolina licensed engineer as required by the NC building code.
- 2. A maximum number of boats that can be stored on the site while being repaired or pending repairs shall be determined during the site plan review process.
- 3. All repair work on small engines and boat motors that require the motors to be running shall be completed within a building. Boats shall be positioned in the building so that the motor is entirely within the confines of the building. All repair work on small engines and boat motors that require the running of motor shall occur only during the hours of 9:00 a.m. to 5:00 p.m. Monday-Saturday.
- 4. A water test tank shall be utilized during the repair of all boat motors that require the boat motor to be running. The propellers and lower units of outboard motors and the submersion of propellers and out drives of inboard/outboard motor that are being repaired shall be completely submerged in water while running. The test tank shall be a tank manufactured for the purpose of testing boat motors.
- 5. Access to the site where boats are parked or stored shall be prohibited during those hours the business is closed.
- 6. Other reasonable and appropriate conditions that may be identified during the site plan review process.

ZONING AMENDMENT CONSISTENCY DETERMINATION

On August 20, 2018, the Dare County Board of Commissioners considered a zoning text amendment application submitted by Jon Midgett Construction LLC. This zoning amendment application seeks to revise the Commercial Services (CS) district to allow small engine repairs/boat repairs and boat engine repairs as a conditional use in this district.

The 2009 Dare County Land Use Plan is the comprehensive plan for unincorporated Dare County adopted by the Dare County Board of Commissioners on December 6, 2010.

A review of the Dare County Land Use Plan found the following policies to be applicable to the zoning text amendment:

Land Use Compatibility Management Topic

Policy # *LUC* # *5*

Dare County encourages the continued existence and development of locally-owned businesses in unincorporated Dare County.

Implementation Strategy for LUC #5 – Inventory of older existing commercial businesses and consideration of zoning amendment to ensure their replacement or repair in the event of damage from a natural disaster.

On June 11, 2018 the Dare County Planning Board discussed the matter but failed to garner a majority vote on a motion to recommend favorable approval. The dissenting votes were in recognition of opposition from an adjoining property owner to the proposed amendment and not inconsistency with the LUP policies.

Based on a review of the Dare county Land Use Plan, the Board of Commissioners finds the proposed Commercial Services amendment to be consistent with the 2009 Land Use Plan. The Commercial Services district permits a broad scope of uses that are compatible with small engine repairs/ boat repairs and boat engine repairs. The addition of these uses to the list of conditional uses in the Commercial Services district does not negatively impact the Commercial Services district.

The Dare County Board of Commissioners hereby adopts the Commercial Services zoning text amendment submitted by Jon Midgett Construction LLC.

would provide an additional layer of protection for the unincorporated areas from franchise businesses that often employ unoriginal, generic, or replicated corporate building designs that are inconsistent with the traditional architecture of the Outer Banks. In addition to the incompatibility of these franchise restaurants with existing coastal village atmosphere, there are secondary impacts such as trash, lines of waiting vehicles, and a decrease in the appeal of the neighborhood that accompany these commercial developments.

The first section of the LUP noted that the needs of the permanent population and the seasonal population vary in terms of what commercial services and goods are desired. Many of the commercial businesses in Dare County are solely focused on the provision of souvenirs and tourist-related goods to the visiting population. The proliferation of these tourist-oriented businesses was identified by a vast majority of the respondents to the Citizen Involvement Poll as an important issue of concern. This concern was also voiced at all of the public input workshops held at the beginning of the update process in 2007. Other jurisdictions have adopted building design standards to address concerns about the aesthetics of these tourist-oriented retail operations. Building design standards do not address the profusion of such retail establishments. The legality of targeting one segment of the retail market and how to do so was identified as an implementation strategy by the Planning Board. Although it may prove extremely difficult to craft an ordinance aimed at tourist-related businesses, there was a strong consensus among the Planning Board that such efforts were worthy of study and research.

Policy LUC #5

Dare County encourages the continued existence and development of locally-owned businesses in unincorporated Dare County.

Implementation Strategy:

1. Inventory of older existing commercial businesses and consideration of zoning amendments to ensure their replacement or repair in the event of damage from a natural disaster. (2011)

Policy LUC #6

Commercial development should be designed to meet the needs of Dare County's unincorporated villages and not to serve as regional commercial centers. The gross floor area limitations of the Dare County Zoning Ordinance and other applicable land use codes shall be used as a tool to manage the footprint of commercial structures. The goal is to manage the size of the commercial structures, which serves as a disincentive for regional commercial centers for location in villages.

SECTION 22-26.1 - CS COMMERCIAL SERVICES DISTRICT

(a) Intent. The CS district is created to provide a setting for various service establishments that are more intense in their scope of activities than retail/office zoning districts but not as intense as those generally found in an industrial setting.

(This district was established as part of the Colington zoning map adopted by the Dare County Board of Commissioners on June 16, 1997.)

- (b) Permitted uses. The following uses, and no other uses, shall be permitted by right:
 - (1) Barber and beauty shops.
 - (2) Marinas.
 - (3) Dry cleaning and laundry pick-up stations including laundromats.
 - (4) Funeral homes.
 - (5) Parking lots.
 - (6) Radio and television broadcasting studios.
 - (7) Shoe repairs.
 - (8) Storage warehouses.
 - (9) Boat building and storage.
 - (10) Public and private utility facilities.
 - (11) Automobile sales and service.
 - (12) Indoor recreation activities.
- (13) Building supply and equipment sales.
- (14) Plumbing supply and equipment sales.
- (15) Cabinet and woodworking shops.
- (16) Building contractors' offices and storage areas.
- (17) Farm machinery supplies, sales, and repairs.
- (18) Mobile home or recreational vehicle displays and sales.
- (19) Boat displays and sales.
- (20) County owned or leased facilities.
- (21) Fire stations, public and private schools, and other public buildings. (Adopted 5-16-11)
- (22) Residential use in conjunction with a commercial use allowed as a permitted or conditional use in the CS district.
- (c) Conditional uses. The following conditional uses, and no other uses, may be permitted, subject to the requirements of this district and additional regulations and requirements imposed by the Dare County Board of Commissioners as provided in Article IX of this chapter or Chapter 152 of this code:
 - (1) Churches.
 - (2) Radio, television, and other types of transmission towers.
 - (3) Automobile service stations.

(d) Dimensional requirements:

- (1) Minimum lot size: 40,000 contiguous square feet of soil not classified as coastal wetland.
- (2) Buffering: A solid wooden or composite material fence no less than 6 feet in height shall be installed along any property line where a commercial use in the CS district abuts a residential use in any adjoining residential district.
 - (3) Front yard: 15 feet.
- (4) Side yard: 10 feet. An additional five-foot side yard adjacent to the street is required for a corner lot.

(5) Rear yard: 20 feet.

(6) Maximum allowable lot coverage by principal use and all accessory uses: 60%.

(7) Height limitation: 35 feet.


(8) Maximum gross building size: 20,000 square feet excluding decks, porches, and similar non-heated space. Non-heated space including decks and porches shall not be used as retail space, for the display of goods, or other commercial activities.

Group developments with a maximum area of 20,000 square feet per individual building, excluding decks and porches.

(Adopted by the Dare County Board of Commissioners on May 6, 2002)

(9) In the event a natural disaster or accidental occurrence leads to extensive damage (in excess of 50% value) of a structure or group development project in existence prior to May 6, 2002, such structure or group development may be repaired, replaced or reconstructed to 100% of its status prior to damage or destruction but no greater unless otherwise authorized by the Dare County Board of Commissioners.

Chairman Woodard called the meeting to order at 9:01 a.m. He invited Rev. Craig Peel to share a prayer, and then he led the Pledge of Allegiance to the flag.

The Chairman asked for a motion to amend the agenda to move item 5 and make it 1A. **MOTION**

Commissioner Couch motioned to amend the agenda moving item 5 to 1A.

Commissioner House seconded the motion.

VOTE: AYES unanimous

ITEM 1 - OPENING REMARKS - CHAIRMAN'S UPDATE

Following is a brief outline of the items mentioned by Chairman Woodard during his opening remarks, which can be viewed in their entirety in a video on the Dare County website –

- Gave details about local events for the law enforcement National Night Out campaign.
- Congratulated the Dare County Boys 8U baseball team on being the Tar Heel League State Champions. Chairman Woodard also commended the County's Girls 12U All Star softball team for competing in the Babe Ruth World Series.
- Applauded the Colonial Inn in Nags Head for the way they rebounded so quickly from an electrical fire.
- Showed a video from the College of the Albemarle highlighting COA's welding program.
- Chairman Woodard asked County Manager Outten and NCDOT Board Member Allen Moran to address the flooding that has occurred in the wake of recent rainstorms - - -.

Mr. Outten explained how the County has tried to find ways to address specific neighborhood flooding issues without creating problems elsewhere. He outlined options to either move standing water or haul it away to an acceptable location.

Allen Moran announced that NCDOT will commission a drainage study for the north end of Roanoke Island. He noted that participation will be needed by all parties and cautioned that implementation cannot happen overnight and that no system can handle 20 inches of rainwater in 10 days. He said a follow-up report will be given on the engineering options that are ascertained in the drainage study.

ITEM 1A - OUTER BANKS DISTILLING - DONATION (MOVED FROM AGENDA ITEM 5)

Public Services Director, Tim White, informed the Board that Outer Banks Distilling has raised money to help replace rusted playground equipment at Rec Park. The owners of Outer Banks Distilling, Adam Ball, Scott Smith, Matt Newsome, and Kelly Bray presented a check in the amount of \$17,500 that was raised from the sale of a specialty product. Mr. Ball explained that this endeavor was a way of giving back to the community. Chairman Woodard accepted the check and thanked Outer Banks Distilling for their amazing gift that will benefit the children of Dare County.

ITEM 2 - PRESENTATION OF COUNTY SERVICE PINS

ITEM 3 - EMPLOYEE OF THE MONTH - AUGUST 2018

Sarah Bradshaw received the Employee of the Month award from Chuck Lycett who described the many ways that the Social Worker is an asset to Dare County.

ITEM 4 - PUBLIC COMMENTS

The Manager outlined the procedure for making public comments in Manteo and via the video link to the Fessenden Center in Buxton. Following is a brief summary of citizen remarks, which can be viewed in their entirety in a video on the Dare County website –

The following comments were made in Manteo –

 Pat Draisey described the serious flooding problem at her property on Daphne Lane. She said the situation has created a health hazard and that pipes need to be cleaned out and debris removed from ditches. Ms. Draisey said developers must be made to plan for drainage and called for a building moratorium on the north end of Roanoke Island until a solution can be found.

- 2. Jim Hoffner explained the steps he has taken to drain his Daphne Lane property and said he has no intention of putting water on someone else's property. He noted that the drainage line to the sound must be properly maintained. Mr. Hoffner said people are frustrated and need information. He offered to be part of the effort to fix the problem and urged the Board to work together with the community to address this.
- 3. J.B. Head voiced the frustration of people on Bradford lane where his house is surrounded by water and uninhabitable. He said the drainage system needs to be maintained and that the County must go to the state and get them to address this on an ongoing basis. Mr. Head noted that having to rent equipment to clean out culverts is unsatisfactory and called on the County and the State to come up with a solution.
- 4. Madeleine VanMiddlesworth provided details about the sewage infested water that surrounds her house on Langley Lane and vividly described how the problem is adversely impacting her family. She said people have been allowed to build without proper drainage plans being in place and urged the Board of Commissioners to develop a comprehensive plan as a matter of public safety.
- 5. Tom Higgins spoke about the stormwater issue on Brakewood Road by giving the history of flooding that has occurred in his area and he reminded the Board that the dry pond was breached back in 2010. He said the sad situation on the north end of Roanoke Island is disgraceful and notified the Board that it is causing people to think about selling their properties.
- 6. Linda Dunnigan addressed the problem on Meekins Drive by calling on the Board to consider the thoughtful statements expressed today and work with the State to find a solution for the drainage problem. She said people know where the ditches are and where they are not draining. She added that everyone needs to get on the same page and work together and urged the County to step up and take action.
- 7. Kathy Jorgensen spoke about Apache Street in Kill Devil Hills noting that the problem in her area is not as bad as the conditions described today by people on Roanoke Island. She provided photos and a written summary of her efforts to protect and preserve her property. Chairman Woodard encouraged Ms. Jorgensen to share her information and express her concerns with the Town of Kill Devil Hills.
- 8. Chrissy Simmons said she is willing to have her Brakewood Road property take on some of the water inundating her neighbors. She noted that a solution is possible and that equipment is available somewhere to solve the problem for the people that are suffering, who she said are not willing to just go away. She said she is willing to serve on a committee to address this and offered to be a point person on this issue.
- 9. Margarette Umphlett described in detail how the severe storm water flooding problem has impacted her property and caused approximately \$50,000 in damages without insurance coverage. She said this has been going on for nearly 3 weeks and asked how much longer will people have to suffer being out of their homes. She said there must be a solution and that she would appreciate the Board finding one quickly.

- 10. Carol Lee Tillett said her property on Holly Ridge Road has never before experienced flooding like this and that the situation is worse than what occurs during major hurricanes. She said toilets have been unable to flush due to standing water and people are having to wade through contaminated water. She begged the Board for help saying we are your people, and we need your help now.
- 11. Mike Tillett said the main problem with storm water flooding is the serious health issues that are associated with it. He said this is the number one concern. He explained that the water needs to be removed as quickly and efficiently as possible before people get sick from disease. He added that the Dare County Building Ordinances may need to be amended.
- 12. Priscilla Cahoon described a flooded property on Burnside Road that has caused a problem for her family. She also identified other areas that need attention. Ms. Cahoon informed the Board of Commissioners that the ditches of Roanoke Island have not been properly maintained. She noted that drainage ditches are being illegally filled up.
- 13. Rosemarie Doshier said she is able to feel the pain that was expressed by the people of Roanoke Island because the same stormwater issues have plagued her East Lake community for many years. She said this issue has not been properly addressed and drainage ditches continue to be clogged by vegetative debris. She noted that this is one of her hot topics of concern as a candidate for the Board of Commissioners.

There were no comments made in Buxton

Following public comments, the Board discussed the stormwater flooding problem and the health risks that were identified by area residents. Chairman Woodard voiced the Board's consensus that the County will do whatever it takes to address this problem immediately and he promised that resources would be promptly mobilized. Later in the meeting, the County Manager reported that equipment is now enroute to Dare County to address immediate short-term needs while an engineering study is undertaken by NCDOT.

ITEM 6 - VFW AWARD PRESENTATION TO ADVANCED EMT BILL LARICOS

Representatives from Dare County VFW Post 10950 honored Dare County Advanced EMT Bill Laricos as the Dare County EMT of the Year and as the North Carolina State EMT of the Year. The awards were presented by VFW Quarter Master Jim Norell, Commander Richard Probst, and Service Officer Fred Lamm along with EMS Chief Jennie Collins and Jack Scarborough representing the Hatteras Island Rescue Squad. Mr. Laricos was commended for his dedicated service and it was noted that he has a broad range of public safety experience including law enforcement, firefighting, and emergency medical services.

ITEM 7 - NORTH CAROLINA GOVERNOR'S HIGHWAY SAFETY PROGRAM (Att. #1)

Sheriff Doug Doughtie outlined a \$20,000 grant opportunity with the North Carolina Governor's Highway Safety Program (GHSP). He explained the purpose of the grant and stated that no local match funds are required. The Sheriff asked the Board to adopt a Resolution authorizing the grant application.

MOTION

Commissioner Shea motioned to adopt the resolution authorizing the grant as presented. Commissioner House seconded the motion.

VOTE: AYES unanimous

ITEM 8 – GOLF CARTS IN BUXTON

Planning Director Donna Creef gave a briefing on research that was done in follow-up to a citizen request to allow golf cart use in the Village of Buxton. She explained that North Carolina law allows golf carts on State maintained roads that have a speed limit of 35 mph or less. She reported that based on a traffic analysis done by Sheriff Doughtie, both she and the Sheriff feel that golf carts on Highway 12 would not be best for public safety, however, other subdivision roads may be appropriate. Ms. Creef noted that Chapter 100, Streets and Sidewalks would need to be amended if the Board wants to consider golf cart operation in Buxton Village and recommended that a Public Hearing be scheduled.

MOTION

Vice Chairman Overman motioned to schedule a Public Hearing for 5:30 p.m., August 20. Commissioner House seconded the motion.

ITEM 9 - PROPOSED REVISIONS TO CHAPTER 99 CAMPING

The County Manager provided background information about the County's revaluation schedule and presented a Resolution to advance the County's revaluation of real property from January 1, 2021 to January 1, 2020 with subsequent revaluations on a five year cycle. **MOTION**

ITEM 13 - RECOMMENDED 2019 CAPITAL IMPROVEMENTS PLAN (Att. #3)

He outlined the impact that the CIP will have on the Capital Reserve fund balance over the next five years and noted that it funds the total amount requested for CIP projects by Dare County Schools. Mr. Clawson outlined 23 projects included in the CIP and explained the planned debt issuances related to the CIP. Mr. Clawson also provided Commissioners with five possible scenarios for a new CIP project for construction of a new Animal Shelter. MEMORANDUM OF UNDERSTANDING

Between

DARE COUNTY, NORTH CAROLINA

And

U.S. DEPARTMENT OF THE INTERIOR U.S. FISH AND WILDLIFE SERVICE

I. Authority:

This Memorandum of Understanding (MOU) is entered into between the Department of the Interior (hereinafter referred to as the Department), U.S. Fish and Wildlife Service (hereinafter referred to as the Service) and Dare County (hereinafter referred to as the County) under the authority of:

Fish and Wildlife Coordination Act (16 U.S.C. 661-667)

The Fish and Wildlife Coordination Act provides authority for the Secretary to enter into agreements with federal and state agencies, as well as public and private organizations, to assist in the protection of fish and wildlife and their habitats.

Fish and Wildlife Act of 1956 (16 U.S.C. 742 et seq.

The Fish and Wildlife Act of 1956 grants the Secretary broad authority to, "take such steps as may be required for the development, advancement, management, conservation, and protection of fish and wildlife resources...."Further, the act specifically authorizes the Secretary to enter into cooperative agreements for programs and projects to benefit specific units of the National Wildlife Refuge System.

II. Background:

The Service now owns and manages approximately 153,500 acres of land in Dare and Hyde Counties, North Carolina as part of the Alligator River National Wildlife Refuge (Refuge). The Refuge's Comprehensive Conservation Plan (CCP) has a cropland objective to manage 3,481 acres of cropland on the refuge, with approximately half managed primarily to produce food for wintering waterfowl and other wildlife and half managed as filter strips to effect water quality and to provide habitat for grassland birds, ground-nesting birds, and other wildlife. The County owns approximately 8:36 acres of land that it operates as part of the Dare County Landfill, which lies adjacent to the eastern portion of the Refuge's Farming Units. The County land also includes fields that are leased for farming.

Prior to the current ownership, the area was logged followed by digging a canal network and using the borrow material to build the adjacent road system. The canal/road system divided the land into blocks that could be drained by pumping. Smaller v-ditches were dug to delineate individual fields within a block. The fields were graded to a crown in the middle of the field so water would follow the slope from the "headland" end towards the "collector canal" end. The system was necessary since the soils do not percolate water as non-hydric soils would. All of the land clearing and grading lowered the elevation of

the farm fields to a point that pumping is necessary to keep water off of them. The collector canals on the County land drain into the canals on the Refuge.

The Refuge operates two pumping stations to drain water off the Farming Units. The Creef Pumping Station, located at the intersection of Long Curve and Grouse Roads, drains water off the Creef Farming Unit lying between Milltail and Bear Roads (see map) and off the County land. The Creef Pumping Station has two John Deere engines and pumps that utilize diesel fuel. Fuel is stored in a 2,000 gallon above ground storage tank. The Refuge operates the Creef Pumping Station to drain the cropland when impacted by weather events and to drain impoundments that have been flooded for wintering waterfowl. The County drains water off its land to facilitate operations of the Dare County Landfill and farming operations on the property.

The Service and the County have a long history of cooperation to facilitate draining water off their adjoining properties in support each other's mission.

III. Purpose

This MOU is intended to outline a framework for cooperation and the general operations of the Creef Pumping Station for the understanding of all parties.

IV. Scope of Effort:

For a period as hereinafter set forth, the Service and the Department shall cooperate as necessary for the performance of work as set forth below:

A. General:

- The Creef Pumping Station, located at the intersection of Long Curve and Grouse Roads, drains water off the Creef Farming Unit and off the County land.
- 2. The refuge has two Cooperative Farming Agreements for farming operations in the Creef Unit. In addition to leaving a share of farmed acres in standing crop in the field for wildlife, the Cooperative Farmers pay a portion fuel costs (approximately two thirds) for the Creef Pumping Station throughout the year.

B. The Service shall:

- 1. Provide the personnel to operate the Creef Pumping Station.
- 2. Perform all preventative and required maintenance or repairs to the Creef Pumping Station.
- 3. Notify the Cooperative Farmers or County when the Creef Pumping Station needs diesel fuel.
- 4. Manage the Cooperative Farming Agreements to ensure all permittees are meeting their fuel obligations.

C. Dare County shall:

- Facilitate the pumping of water off County land by providing diesel fuel to the Creef Pumping Station, not to exceed one third of the Station's fuel needs per calendar year.
- Communicate with the Service on pumping needs to facilitate water drainage off the County land.

V. Period of Performance

The period of performance of the MOU is from the last date of signature by all parties, through a scheduled completion date of December 31, 2021 at which time it will be subject to review, renewal, or expiration.

VII. Modification of Agreement:

This MOU constitutes the full, complete, and entire agreement between the parties hereto. No modification or amendment of this MOU shall be binding on either party unless such modification or amendment shall be in writing executed in duplicate by both parties hereto, attached to this MOU, and incorporated in and by reference made a part of this MOU.

VIII. Termination of Agreement:

Any party to this MOU may withdraw with a 60-day written notice. Such withdrawal shall be effective 60-days from the date such written notice is provided to the other party or parties to the agreement.

IX. Terms and Conditions:

- 1. This MOU in no way restricts the parties from working together or participating in similar activities with other public or private agencies, organizations, and individuals.
- Any public notices issued by any of the parties with respect to this MOU or any related activities shall be subject to review and approval, in advance, by all parties to this agreement.
- 3. During the performance of this MOU the participants agree to abide by the terms of Executive Order 11246 on nondiscrimination and will not discriminate against any person because of race, age, color, religion, gender, national origin, or disability.

- 4. No member of, or delegate to Congress, or resident Commissioner, shall be admitted to any share or part of this agreement, or to any benefit that may arise from, but these provisions shall not be construed to extend to this agreement if made with a corporation for its general benefits.
- 5. All parties will ensure that its employees have the proper training and certification required to conduct activities under this MOU.
- 6. This MOU is neither a fiscal nor a funds obligation document. Nothing in this agreement may be construed to obligate the Service to any current or future expenditure of resources in advance of the availability of appropriations from Congress. Any endeavor involving reimbursement or contribution of funds between the parties to this MOU will be handled in accordance to applicable regulations and procedures, including those for federal government procurement and printing. Such endeavor will be outlined in separate agreements that shall be made in writing by representatives of the parties and shall be independently authorized in accordance with appropriate statutory authority. This MOU does not provide such authority.
- It is agreed by the parties hereto that, in the performance of this MOU, employees or agents of each respective party are not to be considered employees of the other party or parties.
- 8. Nothing in this agreement may be interpreted to imply that the United States, the Department of the Interior, or the U.S. Fish and Wildlife Service endorses any product, service or policy of Dare County. Dare County will not take any action or make any statement that suggests or implies such an endorsement.
- 9. The participation of each party to this agreement in activities conducted pursuant to this MOU is not intended to place either party or its representatives in a position of incurring tort liability arising from an action of the other party. Each party is responsible for any injury or property damage to third parties caused by negligence of its own employees acting within the scope of their employment/official duty subject to such limitation as may be prescribed by applicable laws. Specifically, tort liability arising from negligent or wrongful acts or omissions of Service employees acting within the scope of employment shall be adjudicated pursuant to the Federal Tort Claims 28 U.S.C. Section 2671 et seq., the Federal Employees Compensation Act, U.S.C. Section 8101 et seq., or such other federal legal authority as may be pertinent. Likewise, tort liability arising from negligent or wrongful acts or omissions of the County employees while acting within the scope of official duty shall be governed by the provisions of the laws of the state of North Carolina.
- 10. The parties agree to implement the provisions of this MOU to the extent personnel are available and budgets allow. In addition, nothing in the MOU is intended to supersede any laws, regulations, or directives by which the parties must legally abide.
